National Confidential Inquiry-Action plan	<p>PH Presented the first iteration of the NCI action plan that consists of a number of national and local actions. The group were asked to consider outside the meeting and feedback to PH re any comments.</p> <p>A number of issues were raised about health inequalities and the standardised use of accessible information for health screening for people who do not need that format and the importance of a person centred approach (PCA) to individuals.</p> <p>It was however accepted that primary care had progressed a long way following last years DES audit and individual practice action plans and that a standardised approach for the majority should not be criticised if it did not address the needs of the few acknowledging that PCA should be developed as a principle in all care providers.</p> <p> NCI- Action Plan.xls</p> <p>Action-</p> <p>(1) All to read and feedback if required</p> <p>(2) PH to present first iteration to CCG clinical governance sub committee</p>
