1. Background

The Higher Folds estate is a geographically isolated area served by two small primary schools, Higher Folds Community Primary School and St. Gabriel's Catholic Primary School.

Numbers at the two schools are given in the table below.

- 1.2 The Headteacher and deputy Headteacher of Higher Folds Community Primary School have resigned.

2. Proposals

The Governors of Higher Folds and of St. Gabriel's have jointly discussed their concerns about low numbers of children on the estate and have agreed to the temporary arrangements list below for the 2007/08 academic year.

- The vacant Headteacher post at Higher Folds not be filled.
- The vacant deputy Headteacher post at Higher Folds be filled (possibly on a temporary contract).
- The existing Headteacher of St. Gabriel's be appointed as a temporary executive Headteacher to cover both schools
- The project be reviewed in the Spring and Summer terms 2008.
