**NOTICE OF PROPOSALS**

**THE WIGAN BOROUGH (PASSAGEWAYS TO THE SIDE OF 71 AND REAR OF 73 -101 ATHERTON ROAD, SIDE OF 6 AND REAR OF 14 – 32 ALGERNON STREET, REAR AND SIDES OF 1 BEAUFORT STREET AND REAR OF 93 - 101 PLATT LANE, HINDLEY, WIGAN) GATING ORDER 2011**

Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129A of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers. The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to the Side of 71 and Rear of 73 -101 Atherton Road, Side of 6 and Rear of 14 – 32 Algernon Street, Rear and Sides of 1 Beaufort Street and Rear of 93 - 101 Platt Lane, Hindley, Wigan.

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule. Any representations or objections to the Order must be in writing to the Head of Service, Legal & Risk, Town Hall, Library Street, Wigan WN1 1YN quoting reference RD/LR/JNI/Q44/122- by **27 July 2011**. Please state the grounds on which they are made.

**(Proposed Gating Order)**

**THE WIGAN BOROUGH (PASSAGEWAYS TO THE SIDE OF 71 AND REAR OF 73 -101 ATHERTON ROAD, SIDE OF 6 AND REAR OF 14 – 32 ALGERNON STREET, REAR AND SIDES OF 1 BEAUFORT STREET AND REAR OF 93 - 101 PLATT LANE, HINDLEY, WIGAN) GATING ORDER 2011**

Wigan Borough Council in exercise of its powers under Section 129A of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Wigan hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Passageways to the Side of 71 and Rear of 73 -101 Atherton Road, Side of 6 and Rear Of 14 – 32 Algernon Street, Rear and Sides of 1 Beaufort Street and Rear of 93 - 101 Platt Lane, Hindley, Wigan) Gating Order 2011 and shall come into operation on .....2011.

2. The public right of way along the following passages as shown for identification purposes only on the attached plan is restricted at all times:-

- i) Passageways Side of 71 and Rear of 73 -101 Atherton Road, Hindley
- ii) Passageways Side of 6 and Rear Of 14 – 32 Algernon Street, Hindley
- iii) Passageways Rear and Sides of 1 Beaufort Street, Hindley
- iv) Passageways Rear of 93 - 101 Platt Lane, Hindley

3. Nothing in article 2 of this Order shall apply to:

- a) all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
- b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
- c) persons using the highway for police, ambulance or fire brigade purposes
- d) Council officers on business
- e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council

4. Alternative routes are available via Atherton Road, Beaufort Street, Algernon Street, Platt Lane

5. Gates will be installed at the approximate locations marked on the attached plan and each will be operated and maintained by the Council.

6. The maintenance and operation of the gate will be the responsibility of the Council's Anti-Social Behaviour Co-ordinator who may be contacted at the Environmental Services Department, Civic Buildings, New Market Street, Wigan WN1 1RP.

7. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
