NOTICE OF PROPOSALS

THE WIGAN BOROUGH (PASSAGEWAYS TO THE SIDE AND REAR OF MAYFIELD STREET, THE SIDE AND REAR OF CAMBRIDGE STREET, THE REAR OF HAMILTON STREET, THE SIDE AND REAR OF ARGYLE STREET, THE REAR OF MORLEY STREET AND THE SIDE AND REAR OF MORLEY COTTAGE, ATHERTON) GATING ORDER 2008

Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to (1) the Rear of 29 to 55 Mayfield Street and at the Side of 55 Mayfield Street, (2) the Rear of 2 to 30 Cambridge Street and at the Side of 30 Cambridge Street (3) the Rear of 99 to 123 Hamilton Street and Rear of 2 to 30 Argyle Street (4) the Side of 30 Argyle Street and the Rear of 3 to 29 Argyle Street and at the Side of 29 Argyle Street (6) the Side of 2 to 6 Cambridge Street and Rear of 20 to 34 Morley Street (7) the Side and Rear of Morley Cottage, Atherton,

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN by quoting reference DPLS/BD/Q41/79-/Q-00915 by 14th March 2008. Please state the grounds on which they are made.
