More than 300 local enterprises have signed up to the revamped Deal in the past 12 months, representing 28 different sectors including construction, health and social care, retail and hospitality.

Councillor David Molyneux MBE, Leader of Wigan Council, said "The Deal for Business was originally launched in 2015, and we worked with the local Business Consortium to codesign this new offer to make sure it works for our local businesses.

"I'd like to say a huge thank you to the businesses that have worked with us over this past year. These are unprecedently difficult times for businesses, who are still recovering from the impact of the pandemic and now facing the cost-of-living crisis.

Through the Deal, the council commits to connecting businesses with recruitment and training opportunities, helping with peer-topeer support and hosting an online directory.



Highlights from Our Town 2022

Building on the success of the Our Town programme in 2021, which delivered improvements to twelve district centres, Our Town returned in 2022.

Thirteen district centres were visited between April and October during Our Town 2022: Bryn, Douglas, Atherleigh, Astley Mosley Common, Wigan West, Wigan Central, Leigh East, Leigh West, Shevington, Hindley Green, Worsley Mesnes, Winstanley, and Leigh South.

These areas were spruced up with

8,000 square metres of pavements and pathways jet washed, and 3,000 metres of grass edged off to rewiden and neaten paths.

Forty tonnes of waste were removed, 28 'grot spots' were cleaned up, and all road markings, lighting columns and guard rails were repainted across the Our Town areas; ensuring they are looking their best.

One hundred bins were also installed across the Our Town areas, helping local people to keep their town tidy.

Wigan Council launches 'FAB' grants programme

Wigan Council's Future Apprentices for Business (FAB) grants programme was launched during National Apprenticeship Week.

Unveiled at the Believe in Business Festival, the flagship scheme is open to firms across the borough with grants of £3k or £5k available.

Apprenticeships help businesses to 'grow their own', develop skills for their future workforce, and at the same time create much-needed employment with training for younger people.

To access the grant funding, a business must have a location in Wigan Borough and have fewer than 250 employees.

They must also be setting up a new apprenticeship and recruiting someone aged 16 to 24 who lives in the borough.

To access this funding, businesses must pay at least National Minimum Wage for the apprentice's age. This is higher than the Apprentice Wage, ensuring that these vacancies are attractive to the best candidates.

There are two levels of grant available to local businesses; the £3k basic grant, and a £5k enhanced grant available to businesses that select their apprentice from the council's talent pool.

The talent pool is made up of a selection of apprentice-ready young people identified by our employment and skills programmes, including looked after children and care leavers, young people with special educational needs and disabilities, and those who are not in employment, education or training.
