

Consultation on Proposals for Hope School and College

Introduction

We are writing to tell you about our proposals about Hope School and College and to ask your view.

This proposal follows consultation that took place last year and Cabinet's approval that we strategically develop the borough's special school provision to:

- improve the offer to children and young people
- increase capacity of places
- · develop new provision within mainstream services; and
- improving the condition of our special school buildings.

Phase 1 of the strategy is to address this at Hope School and College.

Current provision at Hope School and College

The buildings on the current Hope School and College site at Marus Bridge are no longer big enough to accommodate the number of learners who need a place there. The buildings also have condition issues that must be addressed. We recently provided a mobile on the school site to ensure we had enough places available to meet demand. This is a temporary solution and not suitable in the long term.

We want our learners to be taught and nurtured in buildings that provide them and their teachers with the required modern space and facilities. We want to ensure that we have adequate places available for the number of children who need this specialist education. That children who live in the borough can access places close to where they live rather than having to travel to other authorities to receive their education. That we can offer outreach support for our learners in mainstream school provision.

Hope School and College is currently categorised with the Department for Education as a community special school catering for children with special needs / complex needs within an age range of 2 to 19 years. The current designated number of places is 200. The school currently accommodates 206 learners.

The number of places available is as follows:

In addition to this, the Hope School and College site also has a mixed ability nursery school provision for 2 to 4 year olds. As well as post 19 social care provision for young adults in The Grange and The Hamlet which is off site provision.

Our proposal for Hope School and College

We are proposing to:

- Rebuild Hope School and College to cater for children age range 2 to 19 vears
- Relocate the school on the Central Park Site on Montrose Avenue, Worsley Hall, Wigan
- Increase the capacity of the Hope School and College so it can accommodate up to 230 children

It is proposed we do this with effect from September 2021.

Nursery provision

The current nursery provides places mainly for children who live locally to the school site and is inclusive of children with SEND. At this stage, we are unable to move the nursery to the new Central Park site as the area is currently sufficient (enough places available) in the catchment area. The current nursery provision on the Hope School Marus Bridge site will remain in place until September 2021. In the meantime, we will be carrying out a sufficiency exercise which will allow us to look at opportunities to continue to provide the nursery provision on the current Hope site or elsewhere within the local community. We will be ensuring the best possible nursery offer is available within the area. We will have a limited number of 2-4 year old places available at the new Hope School on the Central Park site for those children who are assessed as necessary to access the facilities at the school.

Post 19 Provision

The Hamlet based at the Three Sisters, Ashton-in-Makerfield. The Grange at the Marus Bridge site is a post 19 social care provision catering for young adults. This provision will remain in place at the Marus Bridge site until 2021 and will not be moving to the Central Park site. We are working with adult services to look at opportunities and alternatives to ensure we still provide a package of support for young adults post 19.

What this means for you and your children / learners age 2 to 19 years at Hope Special School and College

If this proposal goes ahead, your child will continue to attend Hope School and College until the new school building is completed and the transition process can begin.

We will take extra care when managing transition to the new building taking into account the individual needs of your children.

Transport

Transport will continue to be arranged for eligible pupils in accordance with the transport policy.

Consultation process

We will hold meetings about the proposal and to answer any questions you may have.

Please note that all responses to this consultation will be made available to Elected Members (councillors) for decision making purposes.

We must follow strict legal procedures if we want to reorganise schools. The timetable below shows the periods of consultation and dates when decisions are expected to be made. If you make your views know outside of these periods, or in any other way than described, they cannot be taken into account.
