# Clerk's Report to Haigh Parish Council 9 May 2022

### LG Boundary Commission Proposals for Wigan Council's Ward Boundaries

The Commission were due to publish their final recommendations on 3 May, but this has been delayed to 10 May.

#### **Potential Future Projects**

The design and purchase of two pop-up banners and installation of a new notice board at Leyland Mill Lane are being looked into.

#### Bench in Red Rock Lane

A claim has been submitted to our insurer for the damage to the bench. Because it was suspected that the bench had been damaged as a result of a vehicular collision, the Police had to be informed before a claim could be submitted.

#### **Future Airspace MAN**

The Manchester Airport Future Airspace team are working through Stage 2 of the seven stage, fourteen step, four gateway Airspace Change process outlined in the <u>Civil Aviation Authority CAP1616 document</u>. At this stage, a comprehensive list of route options will be produced, developed through reference to the <u>design principles that were agreed through stakeholder engagement at Stage1</u>. The leader of the team managing the consultation have written:

"During our phase one engagement sessions, in November/December 2021, we outlined the process that we followed to determine 'envelopes' where routes options could be drawn.

I am contacting you to invite to you to attend one of our phase two engagement sessions, where we will explain the changes we made because of stakeholder feedback received in phase one, and present specific route options that align with the design principles and take account of stakeholder views. The SPD has been produced to better manage the provision of HMOs, improve the standards of accommodation provided and reduce detrimental impacts on neighbours. It assists in the interpretation of policies within the adopted development plan and sets out guidance and good practice for planning applicants to enable the delivery of better planning outcomes. The SPD does not address issues in relation to existing HMOs but will be an important material consideration in the determination of planning applications for new and expanded HMOs.

- Is based around ten key topic areas, which are integral to the application of a Health Impact Assessment, for schemes subject to Environmental Impact Assessment screening, and a Planning for Health Checklist for all other major developments.
- Sets out a consistent process for calculating developer contributions to address capacity issues in the health care system that result from new development proposals;
