(EYInc 4 Request for Involvement Privacy Notice)

Wigan Council (“a data controller”) is committed to protecting the privacy and security of your personal information.

Early Learning & Childcare Inclusion Team provides support for children with Special Educational Needs from birth to 5 who access Portage and Early Years provisions in the maintained, P & V or childminding sector.

Our core obligations under the general data protection regulations (GDPR) and commitments are set out in the [Council's primary privacy notice](#).

This notice provides additional privacy information for:

- Early Years Providers
- Parents/Carers
- Professionals across Education, Health and Social Care

It describes how we collect, use and share personal information about you:

- Before, during and after your relationship with us ends and
- The types of personal information we need to process, including information the law describes as ‘special’ because of its sensitivity.

It is important that you read this notice, together with any other privacy information so that you are aware of how and why we use your personal information.

We collect Special Information;

The law treats some types of personal information as ‘special’ because the information requires more protection due to its sensitivity. This information consists of;

- Racial or ethnic origin
- Sexuality and sexual life
- Religious or philosophical beliefs
- Trade Union membership
- Political opinions
- Genetic and bio-metric data
- Physical or mental health
- Criminal convictions and offences

Purpose(s)

The main purposes for processing your personal information are:

- To enable the Early Learning Child Care Team to observe, consult and assess your child to determine the level of support needed for the setting and/or the child as appropriate.
- If a family are requesting Portage, it allows ELCC to contact the family to arrange an initial assessment, in your home, to determine if your child meets criteria for regular home visits from a Portage Worker.
- To enable ELCC to liaise with other professionals for further support and advice that may benefit your child
- To allow ELCC to share information at points of transition with any setting or school which your child is due to attend

Categories of personal data

In order to carry out activities and obligations as an Early Years Inclusion team we process personal information in relation to:

- Name, date of birth, address, setting attended, parents name and contact details, professionals involved.

Special Categories

We may also collect, store and use the following "special categories" of more sensitive personal information:

- Any involvement with Social Care

The legal bases we rely on for processing your personal information are:

- Children's Act 2014 and the SEN Code of Practice 2014

If we intend to use your information beyond legal obligations or to exercise specific rights we will seek your consent to process your information and full guidance will be provided.

AUTOMATED DECISION-MAKING

All the decisions we make about you involve human intervention.

DATA SHARING

In addition to the general reasons for information sharing described in the Council's primary privacy notice:

We also collect or receive information from external parties such as:

- Bridgewater Community Healthcare Trust
- Wrightington, Wigan and Leigh Healthcare Trust

DATA RETENTION

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any future legal, accounting, or reporting requirements.

We must continue to retain necessary information in accordance with our corporate records policy to fulfil legal, statutory and regulatory requirements. The Children's Act 2014 and the SEN Code of Practice 2014.

RIGHTS OF ACCESS, CORRECTION, ERASURE, AND RESTRICTION

- You have the right to ask for your information and there will not be a charge for you to do so. This is known as a [subject access request](#) and we act in accordance with this policy.
- To ask for your information to be corrected if it is inaccurate or incomplete.
- To ask for your information to be deleted or removed where there is no need for us to continue processing it (right to be forgotten).
- To ask us to restrict the use of your information.
- To ask us to copy or transfer your information from one IT system to another in a safe and secure way without impacting the quality of the information.
- To object to how your information is used.
- To challenge any decisions made without human intervention (automated decision making).

You will not have to pay a fee to access your personal information (or to exercise any of the other rights). However, we may charge a reasonable fee if your request for access is in our view unreasonable or excessive. Alternatively, we may refuse to comply with the request in such circumstances.

RIGHT TO WITHDRAW CONSENT AT ANY TIME

Where the legal reason for processing your personal information is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of our processing prior to the withdrawal of your consent.

If you do not provide consent, we may not be able to perform the contract we have entered into with you (EYInc 2 forward planning), or we may be prevented from complying with our legal obligations (SEN Code of Practice 2014).

If you wish to withdraw consent you can contact Joanne Keenan, Early Years Inclusion Manager, Civic Centre, 2nd Floor, Millgate, Wigan WN1 1AZ in writing who will process your request within 14 days.

YOUR RIGHTS

In addition to the above you have legal rights in relation to your personal information. You have a right to be informed about how and why your personal information is being processed. This notice fulfils that obligation.
