(Wigan Music Service Privacy Notice)

Wigan Council (“a data controller”) is committed to protecting the privacy and security of your personal information.

Wigan Music Service (part of the Education Service in the Children and Families directorate provides a wide range of music education services for schools and individual students and their families.

Our core obligations under the general data protection regulations (GDPR) and commitments are set out in the [Council's primary privacy notice](#).

This notice provides additional privacy information for:

- The children the service works with
- The parents of the children who enter into an agreement with us to receive our services

It describes how we collect, use and share personal information about you:

- Before, during and after your relationship with us ends and
- The types of personal information we need to process, including information the law describes as ‘special because of its sensitivity.

It is important that you read this notice, together with any other privacy information so that you are aware of how and why we use your personal information.

We collect Special Information:

The law treats some types of personal information as ‘special’ because the information requires more protection due to its sensitivity. This information consists of:

- Racial or ethnic origin
- Sexuality and sexual life
- Religious or philosophical beliefs
- Trade Union membership
- Political opinions
- Genetic and bio-metric data
- Physical or mental health
- Criminal convictions and offences

Purpose(s):

The main purposes for processing your personal information are:

- To provide you with on-going organisational information about the services you get from us

- To raise invoices for the services you receive from us.
- To enable us to assess applications to our subsidy scheme (The Assisted tuition scheme)
- To process musical instrument procurement through our Assisted Purchase Scheme
- To enable us to complete mandatory paperwork relating to residential and concert tour organisation
- To allow us to comply with juvenile licencing requirements for public performances
- To allow us to look after your child when they are in our care (medical info etc.)
- We will not collect any personal data from you we do not need in order to provide our services to you

Categories of personal data:

In order to carry out activities and obligations as Wigan Music Service we process personal information in relation to:

- Personal contact details such as name, title, addresses, telephone numbers, and personal email addresses
- Personal demographics (including date of birth, gender)
- Basic student medical information (in order to respond to medical needs or questions if a child becomes unwell when in our care)
- Passport details (for overseas tours only) in order to complete travel manifest documents
- For Assisted Tuition Scheme applications only: Household income, benefits you are receiving, other circumstantial details you may tell us about in your application.

Special Categories:

We will not collect, store or use any "special categories" of more sensitive personal information.

The legal bases we rely on for processing your personal information are:

- Legitimate Interests
- Contract
- Legal Obligation
- Consent

If we intend to use your information beyond legal obligations or to exercise specific rights we will seek your consent to process your information and full guidance will be provided.

AUTOMATED DECISION-MAKING

All the decisions we make about you involve human intervention.

DATA SHARING

In addition to the general reasons for information sharing described in the Council's primary privacy notice:

- We will be required to share basic pupil information with LA licencing officers when a juvenile employment licence is required for a performance to take place. This will be limited to Name, Date of Birth and Postcode.
- We will share basic pupil information with music departments in secondary schools in order to assist with the transition of young musicians when they leave primary school.
- We will share student information (passenger info) with agencies and providers involved in our overseas concert tours for senior ensembles and centres who host residential courses here in the UK.

DATA RETENTION

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any future legal, accounting, or reporting requirements.

We must continue to retain necessary information in accordance with our corporate records policy to fulfil legal, statutory and regulatory requirements.

RIGHTS OF ACCESS, CORRECTION, ERASURE, AND RESTRICTION

- You have the right to ask for your information and there will not be a charge for you to do so. This is known as a [subject access request](#) and we act in accordance with this policy.
- To ask for your information to be corrected if it is inaccurate or incomplete.
- To ask for your information to be deleted or removed where there is no need for us to continue processing it. (right to be forgotten)
- To ask us to restrict the use of your information.
- To ask us to copy or transfer your information from one IT system to another in a safe and secure way without impacting the quality of the information.
- To object to how your information is used.
- To challenge any decisions made without human intervention (automated decision making).

You will not have to pay a fee to access your personal information (or to exercise any of the other rights). However, we may charge a reasonable fee if your request for access is in our view unreasonable or excessive. Alternatively, we may refuse to comply with the request in such circumstances.

RIGHT TO WITHDRAW CONSENT AT ANY TIME

Where the legal reason for processing your personal information is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of our processing prior to the withdrawal of your consent.

If you do not provide consent, we may not be able to perform the contract we have entered into with you, or we may be prevented from complying with our legal obligations.

If you wish to withdraw consent you should contact musicservice@wigan.gov.uk in writing who will process your request within 14 days.

YOUR RIGHTS

In addition to the above you have legal rights in relation to your personal information. You have a right to be informed about how and why your personal information is being processed. This notice fulfils that obligation.
