Dear 'redacted'

I am writing this letter on behalf of Wigan Council to formally notify you of our decision to withdraw all of our existing learners at My Life Learning following consideration of all of the available options as a result of their recent OFSTED inspection where they achieved an overall grading of inadequate.

This is not a decision that Wigan Council have made lightly, and have done so taking a number of factors and risks into consideration, but ultimately we perceive it to be in the best interests of our young people to source alternative placements with other commissioned providers, who we are confident can provide access to a safe and quality education.

The significant concerns raised by OFSTED and the lack of pace in which My Life have been able to make necessary improvements (as identified through previous monitoring visits) ultimately mean that the LA have little assurance that the above can be provided at My Life Learning.

Please find below a copy of the letter which has been sent to My Life Learning outlining the LA's decision to withdraw learners, further information relating to the reasons for this and the plans we have in place to support appropriate next steps.

I would like to take this opportunity to thank you for the support, advice and guidance which has been extended to Wigan Council by the ESFA during this time.

1. Who at Wigan Council made the decision to withdraw the contract from My Life Learning?

Following the Ofsted report and concerns raised that the ESFA may no longer fund the placement Assistant Director for Education Cath Pealing made the final recommendation.

2. When was this decision made? Please provide dates and times of meetings which took place within the Council.

A series of informal internal meetings and phone calls were held between appropriate officers in the SEND team, senior managers in that team and the Assistant Director for Education from when the report was published on 1.7.22 with a final decision being reached on 20.7.22.

3. What were the reasons for this decision? Please provide detailed evidence to support the reasons.

If no detailed evidence is available, then please state that no detailed evidence is available.

The provision was inspected by Ofsted in May 2022 the outcome of which was confidentially made known to us on 16th May 2022 by My Life Learning. Wigan LA first had sight of the full inspection report when it was published on 1st July 2022, the report highlights that the provision is inadequate in all four areas with an overall judgement of inadequate. Significant concerns were raised in every area of judgement. Whilst this is the first full inspection the previous inspection in July 2021 highlighted insufficient areas of progress across all areas. We would have expected to have seen some progress across these areas in that time. We do not believe that the provision has the capacity to make the changes necessary at this time to enable learners to continue.

The decision was made based on the information provided within the Ofsted report published on 1st July 2022.

Detail related to safeguarding in the inspection report include:

'Leaders and managers do not provide training for staff or learners about local safeguarding issues, such as the exploitation of young people. They are unclear about the local issues relating to radicalisation and extremism.'

'The arrangements for safeguarding are not effective. Leaders do not ensure that all safeguarding concerns that staff report are followed up appropriately. The safeguarding team failed to identify potential issues such as neglect or to refer concerns to external agencies. The two recently appointed designated safeguarding leads (DSLs) are inexperienced in this role. Current and previous DSLs have not met regularly or formally with learners identified as a cause for concern to ensure that these learners are staying safe. Leaders have failed to put in place robust risk assessments for work placements. They do not assess properly the activities that learners undertake, the environments in which they learn or the people that they will meet, or the transport in which they travel to their placement'

'As a matter of urgency, put in place effective safeguarding arrangements, including prompt identification, referral and monitoring of safeguarding concerns, and the implementation of robust risk assessments. Leaders and managers must ensure that correct food hygiene standards are followed, that staff model appropriate behaviours, and that training is provided for staff and learners about local safeguarding issues, including radicalisation and extremism.'

5. Cath Peeling Assistant Director of Education at Wigan stated in a public article, that the students were not making educational progress at My Life Learning, and this was one of the reasons for Wigan withdrawing its contract with My Life Learning.

The statement was made based on the information provided within the Ofsted report published on 1st July 2022.

Information recorded within the report related to educational progress includes:

'Learners do not develop the substantial new knowledge, skills and behaviours of which they are capable. Tutors do not plan the curriculum to help learners know more and remember more over time. Learners cannot recall their previous learning and activities easily or without significant prompts. Learners do not benefit from a curriculum that prepares them for their next steps.[...] They do not routinely develop their confidence and independence skills.'

'Leaders, managers and governors do not have high enough expectations of staff and learners at the college. The curriculum is not aspirational or challenging. Learners follow a similar curriculum content regardless of their level and ability. Leaders' and managers' curriculum rationale is not clear or understood by staff. [...] The curriculum is unambitious, and the quality of education is uninspiring. [...]Learners do not routinely receive the support that they need to be successful in

their learning. Leaders, managers and tutors do not identify, or embed into the curriculum, the support for which learners are funded.'

'Leaders provide specialist support training for staff, such as sighted guide training. However, leaders do not have robust plans in place to develop tutors' teaching skills to improve learners' educational experiences. Leaders, managers and tutors do not plan or sequence the curriculum logically. Tutors fail to consolidate and broaden learners' knowledge and understanding. When learning about voting as part of the personal development curriculum, learners do not revisit the topic regularly or in different contexts. [...]However, in lessons, tutors and LSAs do not plan activities to help learners improve specific behaviours, such as building confidence. Learners do not develop the behaviours they need to prepare them for work or life in the community.'
