At the January 2022 census there were 2337 children and young people with an EHCP in Wigan and 6934 children and young people at SEN Support level. This is a total of 9271 children and young people with SEND in the borough

8. How many NEET young people are in the Wigan Borough? age 0-4 age 5-11 age 12-16 age 17 - 24

Please note that NEET (Not in Education Employment or Training) refers to young people aged between 16 - 24 years and so the response refers to this age group.

There are 282 NEET young people in the borough currently.

There are currently 119 who are unknown, but this will reduce in September onwards as we receive destination information.

The Aspiring Futures Service track the destinations of all young people in the borough on a monthly basis. We are currently tracking the destinations of young people that have started/returned to education or training in September, so the number of learners in EET (Education, Employment and Training) and NEET (Not In Education, Training or Employment) opportunities is subject to change on a monthly basis, due to the tracking processes we have in place.

9. How many of the NEET young people are registered as SEND? age 0-4 age 5-11 age 12-16 age 17 - 24

There are 49 SEND young people between 16-24 that are registered as NEET that are available to the labour market. Of these 15 are Not Yet Ready for work or learning and 28 are Seeking employment, education or training. There are 6 that are Not available to the labour market.
