| <p>Please may I have a redacted copy (i.e. one which does not contain names, addresses or other information likely to lead to a person on the register being identified) of the latest copy of your Potentially Violent Persons Register aka Restricted Persons Register aka Cautionary Register aka whatever relevant name you know such a register by.</p> <p>This would include (but not exclusive to)</p> <ul style="list-style-type: none"> <li>- serial complainers</li> <li>- violent/aggressive/abusive persons</li> <li>- troublemakers</li> <li>- campaigners/activists</li> </ul> <p>I would also request information on the distribution/circulation of these lists.</p> <p>My FOI request is for copies of redacted copies of the register which only state the reasons why an individual was added to the blacklist, the categorisation of risk attached to that (eg low, medium, high), and how long they were placed on the list for.</p> | <p>The Council does not hold a copy of a register as such. Details of violent persons are held on an electronic system application. Access to the violence warning system is restricted to authorised council officers through the council intranet, so there is no distribution or circulation of the list.</p> <p>The attached file contains details of the current entries on the system and includes the reason why an individual was added. There is no categorisation of risk recorded and all entries are subject to ongoing review – there is no pre-determined period of time for which any person would remain on the list.</p> <p>The Council does not have a system for recording serial complainers, troublemakers or campaigners/activists.</p> |
