Statutory guidance places a responsibility on organisations to contact the Local Authority Designated Officer (LADO) within one working day where it is alleged that a member of staff or volunteer who works with children has:

\*behaved in a way that has harmed a child or, may have harmed a child; \*possibly committed a criminal offence against a child or related to a child; \*behaved towards a child or children in a way that indicates that they may pose a risk of harm to children; \*behaved or may have behaved in a way that indicates they may not be suitable to work with children.
