Response

- 1) Commissioning of services follows a variety of routes, we are part of a regional framework purchasing system across the North West which has lots for residential, SEND, supported accommodation, and IFAs. Aside from this we also have block contracts in place. And make spot purchasing when required.
- 2) Our Frameworks are held via Placement North West and will be advertised via the chest each of these frameworks open throughout the year to allow for new providers. Our Block contract is due to end 16th June relating to supported accommodation. Renovation work will then be undertaken. Currently anticipating advertising at the end of 2023 and early 2024.
- 3) Yes. We require a significant amount of information as part of our due diligence to give us the assurance needed about any providers ability to provide high quality homes. We also expect all provisions to align to the appropriate regulatory body (i.e. Ofsted).
- 4) Yes. At the time of responding to this FOI we have 1 residential home with 3 beds, 1 home for short breaks containing 5 beds, 1 provision due to close for refurbishments which is for 16 plus young people 6 bedded.
- 5) At the time of responding to this FOI 71 Children looked after in all residential childrens homes, 52 young people including separated children (UASC) in supported accommodation aged 16 years and above.
- 6) 16-17 years old are not known as care leavers they are children in care until they are 18 years of age, we have 25 young people aged 16-18 who live in residential care homes.
- 7) The average cost of a residential home for a looked after child was £3742

- 11) At the age of 18 our UASC children moved to HMO, therefore not living in supported accommodation. Our care leavers also moved on from supported accommodation.

- 13) We have a strong offer locally in Wigan and relationships with a number of providers. We are always looking to develop our relationship with the market, and would welcome a conversation with you on that basis.
