### WIGAN BOROUGH COUNCIL (PUBLIC FOOTPATH HINDLEY NO. 45) EXTINGUISHMENT ORDER 2023

This Order is made by Wigan Borough Council ("the Authority") under Section 118 of the Highways Act 1980 because it appears to the Authority that the footpath described in paragraph 1 below is not needed for public use.

#### **BY THIS ORDER:**

- 1. The public rights of way over the land situate at Public footpath Hindley No. 45 shown by a continuous bold line on the map attached to this Order and described in the Schedule to this Order shall be extinguished 28 days from the date of confirmation of this Order.
- 2. Where immediately before the date on which the footpaths are extinguished there is apparatus, in, over, along or across them belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

#### SCHEDULE

## DESCRIPTION OF PATH TO BE EXTINGUISHED

Public footpath Hindley No. 45 is described in the Definitive Statement for Hindley as: "From Lower Hollins footpath No. 43 south-eastwards to Long Lane near Birch Farm."

This public footpath is to be stopped up from its junction with Borsdane Avenue at point A on the plan at grid reference 362600 404265. The public footpath then heads in a generally south easterly direction for approximately 955 metres to point B on the plan at grid reference 363235 403758 at its junction with Long Lane.
