

WHITEHEAD LANDFILL, LOWER GREEN LANE, WIGAN, M29 7JZ

We are currently undertaking a preliminary investigation of the above site and would be grateful if you could provide us with any of the following information, which will assist us in identifying any ground contamination issues relating to both the site and the surrounding area.

1. Landfill Sites

Any areas of landfilling (closed or operational) on or within a 500m radius of the site, to include where possible:-

- Waste management licence/disposal licence no.
- Types of waste accepted at the site (including volumes if known)
- Licence issue and cancellation date
- Location map and grid reference
- Depth of waste and previous land use of site
- Any engineering data, including lining systems or environmental monitoring
- Details of any active landfill or leachate control measures

2. Contaminated Land

Has the site or any areas of land in the immediate surrounding area been classified as 'contaminated land' under the provisions of Part IIA of the Environmental Protection Act 1990? If no determinations have yet been made regarding this legislation are there any currently known reasons that would affect the future classification of this site.

3. Part A & B Authorised Processes

Is the site or has the site been occupied by an authorised process? Are there any Part A or Part B authorised processes within a 250m radius of the site?

4. Nuisances

Have there been any instances of nuisance associated with the site or immediate surrounding premises? Have any formal notices been issued by the Authority?

5. Reported Incidents

Please advise if there have been any reported spillages or other incidents associated with the site or neighbouring premises.

6. Water Abstractions

Are there any private water abstractions within a 1km radius of the site. If there are where are they, what is abstracted, vol, etc.

Records indicate the landfill consists of construction and demolition wastes of unknown composition, therefore we cannot rule out the possibility of gas producing materials being incorporated into the fill.
