The LA has an Ethical Community Living Framework which it calls off for individual packages of home care based on assessed client needs. Packages remain in place until clients no longer require support, there are no set end dates. The Home Care contract is from 1st April 2022 for a period of 5 +1 +1 years

The LA has an ethical framework of home care providers, aligned strategically to our neighbourhoods. We do not currently have any issues with home care capacity and do not have a waiting list for home care in the borough.
