

Request

I would like to request the following information concerning special educational needs:

- 1. What percentage of children who are due to receive an assessment for an educational health care plan (EHCP) receive an assessment within 20 weeks?
- 2. What is the equivalent percentage for the years: 2022, 2021, 2020, 2019, 2018, and 2017?
- 3. How many children who are currently due to receive this assessment have been waiting for one for 20 weeks or longer?
- 4. How many requests for an assessment were there in the years: 2023, 2022, 2021, 2020, 2019, 2018, and 2017?
- 5. For each of these years, what percentage of requests for an assessment did the council approve?

If you feel that it would be more appropriate to give these year-by-year figures in terms of school year (e.g. 2022-2023), then I would appreciate it if you could do so, so long as the information still goes back to September 2017.

Response

- The 20-week timescale is the statutory process whereby the Council, in line with the Children and Families Act 2014, considers the initial request for an assessment, completes the assessment and makes the decision whether to issue an EHC Plan and issues the final EHC Plan.
 - At the end of 2023, Wigan Council issued 52.8% of EHC Plans within the 20-week timescale. This is provisional data and is subject to change until final publication by the Department for Education in June 2024.
