

# REQUEST 18040

I am writing to request information regarding children and young people under your care or known to your services — particularly those classed as being in crisis and presenting with significant behavioural or mental health challenges.

Specifically, I would like to request the following:

## 1. Children in Crisis Placements

Please provide the number of children and young people (under 18) under your care or known to your Trust in the last 12 months who:

- Have been classed as being in crisis due to mental health or behavioural issues (e.g. anxiety, depression, detachment disorders, aggression, communication difficulties linked to trauma or neglect)
- Required specialist care placements with enhanced staffing ratios or 1:1 / 2:1 supervision

# 2. High-Cost Care

Of those identified above, how many have required placements (e.g. Tier 4 CAMHS beds or bespoke community packages) with weekly costs in the following ranges:

- £16,000
- £17,000
- £18,000
- £19,000
- £20,000
- £24,000-£25,000
- £26,000-£30,000
- £31,000-£35,000
- £36,000-£40,000
- £40,000+

## Please also include:

- A brief description of the care setting (e.g. inpatient CAMHS unit, out-of-area residential placement)

#### **RESPONSE**

We cannot collect this information systematically as we do not have a field for recording 'crisis' however a physical review of the information we have available has provided the following for all children who are or have been in our care in the last 12 months.

18 young people

We have a classified specialist placements as those where we pay for additional support in terms of:

1:1 - 1 2:1 -11 3:1 - 2

T4 Mental Health – 1 Secure – 3

Children in our care in the last 12 months who fit within the pricing bracket is 2 only

2 YP at 20k plus but under £24k – High levels of staffing solo provision, 3:1, complex needs. One in area and one out of area.
