

## REQUEST 18062

I did several searches for SL demand in Wigan and it looks like you have a high demand for older people, individuals with disabilities, and those with mental health needs but the availability is limited. We would be grateful if you could provide the following information under the Freedom of Information act:

- Current and future demand: What types of supported living accommodation are currently in high demand (for adults with learning disabilities, young people, mental health, complex needs, etc?) Are there particular areas or postcodes within SWigan where the need is especially high?
- 2. **Design guidance**: Does the council provide any guidance or preferred standards/specifications for properties to be used for supported living (accessibility features, room sizes, layouts...?)
- 3. **SL providers**: Which supported living providers does the Council currently work with or commission services from?

- 4. **ICB Contact**: Who in the Greater Manchester Integrated Care Board should we contact regarding SL in Wigan? Can you include their name, role, and preferred contact details (ideally including a phone number) please?
- 5. **Housing Authority contact**: Who is the relevant contact in the housing or adult social care department for discussions around SL accommodation? Please provide their name, role, and contact details.

The Council is however delivering the following initiatives in relation to empty homes:

A pilot Empty Homes Investment Scheme, whereby financial assistance is available to refurbish homes that have been empty for 2 years or more and bring them up to a good lettable standard; these homes are then taken onto a lease with the Council and used as general-needs, affordable rented accommodation for local families.

Providing empty homes opportunities to local developers, landlords and investors through our Landlord Hub platform.
