1. How many injuries were reported by council staff (either fully employed or contractors) in 2022/23, 2023/24 and 2024/25?

2. For 2024/25 only, please break down reported injuries by the type of injury sustained and the staff member's job role.

2022/23 = 208 2023/24 = 282 2024/25 = 252
