6. How many residential properties were protected by new flood defences (including all flood mitigation measures) in 2023 and 2024, as well as 2025 year to date. Please split between existing properties and new build developments.

6. Property-level flood protection measures:

Responsibility for property-level flood protection lies with individual property owners. While we are aware that some residents have installed protective measures, we do not maintain a formal record of these installations.

Since 2023, the Council's Flood Risk Team has implemented several schemes aimed at reducing flood risk, including:

- **Bickershaw Lane:** Installation of attenuation ponds to reduce flood risk for approximately 24 properties.
- The Rise and Key Route Network: Installation of leaky dams to help protect 2 properties and key infrastructure.
- Gathurst (near the station): Opening of a culvert to reduce flood risk for 2 nearby properties.

Please note that this does not include ongoing schemes being developed in partnership with the Environment Agency and United Utilities, nor does it reflect works undertaken by other teams within the Council.
