The pitch of the roof is steeper than that of the adjoining bungalow. The dormer has been constructed of light brown uPVC panelling and the new roof tiles are dark brown. These works do not benefit from permitted development rights.	Remove the dormer and roof works as detailed in the refused retrospective planning application A/18/86433/HHRET and reinstate the roof prior to the works being undertaken in accordance with drawing number 1849-1000 which was submitted with the retrospective planning application. These works are to include: <ul style="list-style-type: none"> Reinstatement of the original roof plane and porch roof plane to mirror the neighbouring features at 11 Wellfield Road. This is to be done with the main roof pitches to match those at 11 Wellfield Road and a hip to the roof plane facing the Grasscroft Road side boundary. The materials used are to match in colour size and form those at the attached neighbouring property at 11 Wellfield Road. Reinstatement of the previous front and rear dormers. These had a flat roof no higher than the original ridge on the swelling as shown on drawing no 1849 - 1000. No part of the reinstated dormers should extend beyond the hip point of the original roof to the front and rear and the dormers to both the front and rear are to be set 400mm back from the retrospective main front and rear elevations of the dwelling. 	21/10/2019	No further information, enforcement ongoing.
