



## **REQUEST 18917**

For each planning reference, I would be grateful if you could include (where available):

- The planning application reference number
- The date the Section 106 agreement was entered into
- The type or purpose of the contribution (e.g. education, highways, open space)
- The amount secured
- The amount received by the council
- The amount unspent to date
- Any expiry or repayment date specified in the agreement (if applicable)

I would prefer the information to be provided in spreadsheet or CSV format if possible.
