We have an ongoing participation
strategy that ensures young people are
continuously providing feedback on the
services they use including youth
provision – this is a partnership
approach and is led by the local
authority youth service and the local
commissioned universal youth service
provider. We also have a Youth
Inspection Framework, and our youth
inspectors have completed around 15
youth inspections of different
organisations delivering services for
young people over the past year.

report and is gathered with a wide
range of medium using the Lundy
model of participation.
