How much has been spent on damage repair on council houses, where filthy, verminous, hoarding or biohazard has been mentioned as part of the report?</p>	<p>All costs associated with the deep clean or clean-up of a property are included in the figures provided above.</p> <p>We are unable to provide a detailed breakdown for this question because doing so would exceed the appropriate limit set out under Section 12 of the Freedom of Information Act 2000. To identify these costs, we would need to manually check the repair history of over 800 properties to confirm what work was raised and its associated cost.</p> <p>The time taken to retrieve, review and populate accurate data was 3 hours. We estimate that checking all addresses would take around 77 hours and 15 minutes (calculated as 5 minutes per property), which exceeds the cost threshold considered reasonable under the Act.</p>
