Please provide a breakdown of costs incurred by the Council in relation to Planning Appeals for each financial year from **2010/11** to the current date in **2025**.

Specifically, I request the data be provided in a table format containing the following two categories:

1. The total amount spent by the Council on legal fees, external consultants, and administrative costs for defending planning appeals.

2022/23 = £42,191 excluding VAT.

2023/24 = £0

2024/25 = £0

To note: The figures provided relate solely to external expenditure, such as legal advice, representation, and specialist consultants. They do not include internal costs, which are substantial. In particular, officer time spent preparing and managing appeals represents the largest element of the Council's resource commitment in this area, but these costs have not been quantified. Similarly, the use of Council facilities for hearings and inquiries, often the most technologically equipped rooms available to meet the requirements of such proceedings, and any necessary printing has not been costed for the purposes of this response.

Prior to the above dates the Council does not hold this information in a readily reportable format. Retrieving it would require manual interrogation of historic case files and financial records. We estimate this would exceed 18 hours of officer time, surpassing the £450 cost limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004. Accordingly, under Section 12 of the Act, we are not obliged to comply with this part of your request.
