1. Introduction

- 1.1. This Infrastructure Delivery Plan is a supporting document providing part of the evidence base for the Wigan Local Plan and the Community Infrastructure Levy. It covers the period from 2011 to 2026. It should be read with the Infrastructure Needs Assessment which accompanies the Infrastructure Delivery Plan.
- 1.2. The purpose of the Infrastructure Delivery Plan is to identify the infrastructure required to meet the spatial objectives and growth anticipated in the Wigan Local Plan; show that the required infrastructure is deliverable; and identify where additional investment may be required. This will enable the council to identify possible mechanisms for reducing funding gaps and will provide the basis for the development of the Community Infrastructure Levy.
- 1.3. The Infrastructure Delivery Plan is not a shopping list for developer contributions, nor is it a way of capturing every project being planned for each council or partner service. It recognises there are other plans and strategies that exist which provide more detail about what, how and when key elements of infrastructure will be delivered, and strongly draws on these to inform this Infrastructure Delivery Plan.
- 1.4. The importance of infrastructure planning in delivery of local plans is highlighted in the National Planning Policy Framework (NPPF). Paragraph 162 states: "Local planning authorities should work with other authorities and providers to:
 - assess the quality and capacity of infrastructure for transport. water supply, wastewater and its treatment, energy (including heat), telecommunications, utilities, waste, health, social care, education, flood risk and coastal change management, and its ability to meet forecast demands; and
 - take account of the need for strategic infrastructure including nationally significant infrastructure within their areas.
- 1.5. The Core Strategy, which was adopted in September 2013, is a key component of the Wigan Local Plan. It identifies an appropriate spatial strategy and associated core and spatial policies to guide development within the borough. Through these policies the Core Strategy seeks to achieve an improved quality of life for the local community and ensure environmental, economic and social wellbeing. This, however, will only be achieved if the strategy can be successfully delivered.
- 1.6. The Allocations and Development Management Plan will provide detailed planning policies and site allocations for housing, employment and other types

of development to meet local needs to 2026. Public consultation on a draft plan will take place in Spring 2015 with an aim of adoption in 2016.

- 1.7. The implementation of a successful Local Plan is reliant upon sustained collaboration between the council and a wide range of other organisations and public bodies. This requires a shared vision and shared objectives, and a commitment within all related strategies to deliver essential infrastructure as and when required. This necessary integration between organisations has not always occurred to the detriment of place shaping and the development of sustainable communities, but this Infrastructure Delivery Plan and our partnership working will address these issues.
- 1.8. The development of the Infrastructure Delivery Plan was primarily through combination of infrastructure audits and infrastructure issues identified in Topic Papers which provided the evidence base for the Wigan Local Plan Core Strategy. This enabled current provision to be established and identified any gaps or capacity issues.
- 1.9. Infrastructure providers who have been involved include:
 - **Transport** the council's Highways and Transport Strategy teams, Transport for Greater Manchester, National Rail, Highways Agency
 - Utilities Electricity North West and National Grid, United Utilities
 - **Waste** the council's waste management team, Greater Manchester Minerals and Waste Planning Unit
 - **Flooding** Environment Agency
 - **Health** Wigan Clinical Commissioning Group, Wrightington, Wigan and Leigh NHS Foundation Trust
 - Education the council's People Directorate, Wigan and Leigh College
 - Emergency Services Greater Manchester Police, Greater Manchester Fire and Rescue, North West Ambulance Service
 - Leisure and Culture Wigan Leisure and Culture Trust
 - **Housing** the council's Housing services team, Wigan and Leigh Housing and developers
 - **Green Infrastructure** Wigan Leisure and Culture Trust, the Greenheart Board, Canals and Rivers Trust, Bridgewater Canal Trust
- 1.10. The remit of this Infrastructure Delivery Plan is to demonstrate that the Local Plan is both realistic and deliverable, in accordance with the NPPF, and can therefore be successfully implemented. It identifies:
 - What and where infrastructure is required to deliver the Local Plan;
 - Who is responsible for delivery;
 - **How** the infrastructure will be delivered through the identification of delivery mechanisms and funding sources;
 - When infrastructure will be delivered, with phasing and costs in broad terms;
 - An effective monitoring and review process.

1.11. The Infrastructure Delivery Plan is as comprehensive a document as possible and has taken account of a range of programmes which impact on spatial planning. However it has been prepared during a period of unprecedented change following the banking crisis, subsequent economic recession and public expenditure reductions by the coalition government; meaning that there are many uncertainties and there will inevitably be more changes. It is an evolving document and will be reviewed and monitored regularly to ensure that it includes the most up to date information. Any identified costs are based on the best available information at the time and will be subject to change during the plan period.

2. Infrastructure requirements

2.1. The table below identifies the various infrastructure types under the headings of physical, social and green infrastructure that are included in this Infrastructure Delivery Plan and the associated Infrastructure Needs Assessment.

Infrastructure types

2.2. Infrastructure has a broad definition so it is important to be clear what we mean by infrastructure in this Infrastructure Delivery Plan. Essentially, 'infrastructure' means the facilities and services that help people to live their everyday lives. This can range from strategic provision, such as new schools, health facilities and flood prevention schemes, to the provision of open space and streetscape improvements.

- 2.3. This infrastructure is essential to support the Local Plan objectives of increased housing provision, which will be required due to projected increases in population and households, economic growth, mitigating climate change and of creating thriving and sustainable communities.
- 2.4. In Wigan some forms of infrastructure provision have historically not kept pace with development. This has been a contributory factor to some issues such as a congested road network, deficiencies in open space provision and poor access to key facilities in certain areas. There is concern that future growth will intensify this problem unless a co-ordinated effort is made to address identified deficiencies and that essential infrastructure accompanies new development at all times. It is therefore fundamental that responsible agencies, within their Plans and Programmes, commit the necessary resources required to deliver this infrastructure alongside development.
- 2.5. The Infrastructure Needs Assessment establishes current infrastructure capacity within the borough and identifies initial infrastructure needs associated with further growth. A series of infrastructure issues are identified and these are brought together in Appendix 1. These issues and the range of facilities needed to support development have informed preparation of an infrastructure schedule.
- 2.6. The Infrastructure Schedule in Appendix 2 identifies committed and planned infrastructure from both the public and private sector. It also provides an overview of the infrastructure required to deliver the Local Plan and identifies, where known, who is responsible for delivery, likely costs, a broad indication of phasing, and funding mechanisms. The Schedule also identifies the Local Plan Core Strategy policy relating to the infrastructure and status of the schemes.

3. Delivery mechanisms / agencies

- 3.1. The preparation of the Local Plan including this Infrastructure Delivery Plan has involved substantial engagement between the council and a variety of key delivery agencies. In order to deliver the Local Plan effectively, it is fundamental that these partnerships are maintained.
- 3.2. At the regional and sub-regional level this will be through existing liaison arrangements particularly through the well developed structures of AGMA (Association of Greater Manchester Authorities). At the local level this will often involve dialogue with the partners within well established partnership structures and with various infrastructure liaison groups.
- 3.3. Wigan is one of ten local authorities in Greater Manchester that have been working together collaboratively on many matters of mutual interest since 1986

through AGMA. Wigan Council is committed to working with city regional partners to provide the infrastructure necessary to support the regeneration of the Manchester City Region, provide the 'quality of place' and secure a future for our residents. The Manchester City Region received statutory status in 2009. The ten authorities in Greater Manchester were the first in the country to develop a statutory Combined Authority which will co-ordinate key economic development, regeneration and transport functions. The Greater Manchester Combined Authority (GMCA) was established on 1 April 2011. New powers have recently been agreed for the GMCA including a directly-elected mayor and greater local control over certain budgets.

- 3.4. Many forms of infrastructure operate across administrative boundaries. Transport and waste infrastructure matters are already addressed at a Greater Manchester level and the 10 districts are progressing flood risk, water management and energy planning within a coherent Greater Manchester context and governed by the Manchester City Region commissions. Clearly issues such as river catchments, United Utilities water management catchments, energy supply and distribution and other infrastructure networks do not stop or operate at artificial administrative boundaries.
- 3.5. Wigan has a long history of successful partnership working with strong relationships across the public sector and with private sector partners. This has ensured a corporate commitment to infrastructure management and delivery in the borough. Following a review of partnership working arrangements, the current approach is:
 - The Leaders' Summit setting the direction.
 - The Wigan Forward Board, the Health and Wellbeing Board and the 3rd Sector Assembly forming the core of our partnership working.
- 3.6. In addition, the council will play a key role in infrastructure delivery as local planning authority through the development management process (particularly when seeking developer contributions) and also as a service provider through its service delivery plans.
- 3.7. Regardless of the many changes that have been made, the Infrastructure Delivery Plan can play a key corporate role with partners. It will support and inform other strategies and decisions relating to capital investment. It will influence how funding should be distributed from sources such as planning obligations and the council's Capital Programme.

4. Funding

4.1. A variety of funding sources and mechanisms will be required to achieve the level of growth needed to deliver the Local Plan. Funding sources generally fall into one of two categories: public sector funding and developer contributions.

Public sector programmes

- 4.2. Wigan Council has a capital programme which currently covers the period 2014 to 2017. The present total forecast resources over this period is £195 million broken down by:
 - 2011 / 2012 = £56.5 million (outturn)
 - 2012 / 2013 = £62.8 million (outturn)
 - 2013 / 2014 = £54.0 million (outturn)
 - 2014 / 2015 = £94.3 million
 - 2015 / 2016 = £56.4 million
 - 2016 / 2017 = £44.1 million
- 4.3. However the programme is generally committed with limited growth areas (for example a significant proportion of the total is allocated for planned maintenance following a major 10 year investment in the Decent Homes Standard for council housing). Any future schemes will be subject to new government allocations.
- 4.4. While this represents a significant programme it is lower than anticipated in previous years due to public expenditure reductions and changes of government policy since 2010. A number of projects included in the capital programme which directly relate to the Local Plan objectives have been included in the Schedules in Appendix 2. A number of projects could in the future be directed and aligned with developer contributions to support the delivery of the Local Plan.
- 4.5. Other public sector infrastructure investments may have been delayed or reduced but there are still opportunities to fund proposals and new opportunities to bid for funding. Efforts will be made to maximise contributions from a wide range of other funding sources such as such as the Local Enterprise Partnership, particularly the Regional Growth Fund, European Union, Homes and Communities Agency, New Homes Bonus, utilities funding, the Lottery organisations, public sector land pooling, private investment, joint ventures with landowners and any new funding opportunities that emerge; such as the recently agreed devolved powers to the GMCA. Wigan has a long track record of successful bidding for funding and there is no reason to expect that this will not continue in future.
- 4.6. Delivering existing services more efficiently, for example through the colocation of services to give improved access for local residents to services, can also provide additional capital to fund infrastructure schemes. Co-locating public services such as schools, leisure and cultural facilities into multi-use buildings, also involving a variety of partners beyond council services, within Wigan Borough is already well underway. Recent co-located schemes include a number of new Health Centres, the Wigan Life Centre and a network of

Local Life Centres, based in Atherton, Platt Bridge, Leigh, Ince and Marsh Green, which each provide easily accessible customer services under one roof.

Developer contributions

- 4.7. The council will make every effort to maximise developer contributions received through the planning process. The council is well aware that significant developer contributions are required if the spatial strategy, in particular the delivery of the key strategic site and broad locations for development, is to be realised. In view of this, the council's 'developer contributions' policy CP18 in the Local Plan Core Strategy will seek to improve the process in negotiating and securing developer contributions associated with new development.
- 4.8. The Community Infrastructure Levy (CIL) came into force in April 2010. CIL is a flexible new local levy which local authorities in England and Wales can choose to levy on most new developments in their area in order to secure funding for vital local and sub-regional infrastructure. It is a pro-development tool, aimed at providing valuable top up funding for the infrastructure necessary to unlock housing and economic growth. The council is in the process of preparing a Community Infrastructure Levy (CIL) Charging Schedule with the intention of adoption by Summer 2015.
- 4.9. The proposed Community Infrastructure Levy offers an alternative approach to developer contributions. Unlike section 106 agreements, CIL will be a fixed, standard charge and will therefore not be negotiated on a case by case basis. Consequently, it has the potential to deliver more developer funding than does section 106. Affordable housing will continue to be funded through section 106 rather than CIL.

Funding gap

- 4.10. The summary table at the end of Appendix 2 shows that investment in infrastructure projects completed between 2011 and 2014 was in excess of £116 million. Schemes committed or planned between 2014 and 2016 are in excess of £272 million. Only a very small percentage of this investment is from developer contributions.
- 4.11. However there will be considerable gaps in funding for some of the infrastructure provision which is considered to be essential to deliver the level of growth set out in the Local Plan. It is estimated that the infrastructure funding gap is around £150 million, taking into account projects still to be confirmed. The main infrastructure requirements are for transport, education, recreation and open space, community facilities and health.

- 4.12. The funding gap is significant but the overall picture is not complete as there are a number of unknowns for some projects, particularly in later years. The funding gaps for these infrastructure projects will depend upon what additional sources of funding can be secured. A more accurate picture of costs and funding will gained as projects get closer to delivery.
- 4.13. As indicated above, there are many funding sources available to the council and other public sector organisations to fund infrastructure and there is every likelihood that significant amounts of funding will be achieved. Clearly CIL cannot be expected to pay for the entire infrastructure required to support growth and will only be a small element of the overall cost. A contribution from CIL will not be needed for those projects that do secure full funding from other sources.

5. Monitoring and review

- 5.1. Monitoring and review is a crucial element of the infrastructure planning process. It will enable information to be updated as appropriate and allow assessment as to whether policy objectives are being achieved. It will normally be necessary to review the Infrastructure Schedules on an annual basis.
- 5.2. In parallel with this, the Annual Monitoring Review is required to report progress on policies and related targets in Local Development Documents and will provide an opportunity to show how infrastructure is being delivered to support the Local Plan.
- 5.3. The original Infrastructure Delivery Plan was published in August 2011 at the time of submission of the Local Plan Core Strategy.
 - An updated Infrastructure Delivery Plan was published in February 2013 to provide evidence at the reconvened examination of the Local Plan Core Strategy. The Local Plan Core Strategy was adopted on 11 September 2013.
 - A further updated Infrastructure Delivery Plan was published in February 2014 to provide evidence for consultation on the Community Infrastructure Levy.
 - This updated Infrastructure Delivery Plan, September 2014, provides evidence for submission of the Community Infrastructure Levy and for consultation on the Allocations and Development Management Local Plan.
- 5.4. The updated Infrastructure Delivery Plan, September 2014, is primarily a review of the Infrastructure Schedules, set out in Appendix 2, to reflect changes since February 2014, showing:
 - Schemes completed
 - Changes to schemes and new schemes that have been developed.

Appendix 1 – Infrastructure Issues

A number of gaps, capacity issues, opportunities and / or areas for development were identified as infrastructure issues as part of the infrastructure audits which were brought together in the Infrastructure Needs Assessment. These are set out below:

1. Physical Infrastructure

1.1 Transport

Walking and cycling

 On road and traffic-free cycle and walking routes need to be joined-up and link origins and destinations effectively, taking advantage of rights of way and National Cycle Network routes, and developing new routes where needed and opportunities allow, such as at Northleigh Park and the broad location for new development. Conditions for walking and cycling also need to improved, including route surfacing and maintenance, environmental quality and safety.

Bus and rail network

- The network of quality bus corridors needs to be further developed. Leigh and Tyldesley are poorly served by public transport to / from Manchester city centre. The proposed Leigh-Salford-Manchester Busway is still awaiting funding.
- Interchange facilities between the two rail stations in Wigan town centre and bus and taxi are poor. Public transport interchange at other rail station and at local centres is also poor.
- There is a need for better park and ride facilities at Atherton, Hindley and Gathurst stations. Improved track and signalling and additional and better rail rolling stock are also needed, as is electronic information and CCTV at stations.

Strategic road network

• There are weaknesses in the strategic road network in the borough particularly on east-west routes.

1.2 Energy

- We are highly reliant on non-renewable energy imported from outside the borough.
- In order to achieve zero carbon development and reduce the borough's carbon emissions, there will need to be investment in low carbon energy networks.
- There are energy capacity issues in the borough, particularly the south, that could restrain growth.
- There is the potential for large reductions in carbon dioxide emissions through improvement programmes in schools, other public sector facilities, and through major development schemes.

• There is potential for heat networks in the borough. To take advantage of this, investment will need to be made in the heat delivery infrastructure – linking heat generation with end users.

1.3 Utilities

- Water pressures are known to be generally low in some areas of the borough and there may be a need to provide local water network reinforcement for significant developments at the expense of the developer.
- We need to ensure that the appropriate infrastructure is in place to deal with surface water run off before development can take place.
- The level of proposed new housing and employment development, within some of the proposed broad locations and elsewhere in specific areas of the borough, is likely to result in the need for investment in the water supply network, sewerage infrastructure and wastewater pumping stations.
- Where United Utilities apparatus affects a proposed development site, appropriate works / mitigation measures must be carried out before development commences.
- There is a known risk of flooding from local sources in a few locations within Wigan Borough. Some of these locations, in time, will require management intervention and this may include improvements to infrastructure.

1.4 Waste

Infrastructure issues will be identified and dealt with as part of the preparation of the Greater Manchester Joint Waste Development Plan Document.

- There is a need to identify sites and areas that are suitable for new or enhanced waste management facilities.
- There is a need to reduce waste movements and, where waste needs to be moved, to promote the sustainable movement of waste across the sub-region.

1.5 Economy and employment

- Improved accessibility, through new and improved road infrastructure, is fundamental if the borough is to attract new businesses, including growth sectors, and meet modern business needs. Development within the broad locations and at the key strategic site at Northleigh could deliver such new and improved road infrastructure.
- There is a need to improve the transport infrastructure of the borough to enable residents to access job opportunities more easily.
- Although the borough can boast 100% second-generation broadband coverage, the prices charged by providers means that connection is too expensive for the majority of the borough's businesses to access. In order to compete effectively in economic terms, a more affordable connection to the internet is needed.

- A large proportion of the borough's existing employment accommodation is old, in poor condition and / or not of the right type or specification to meet modern business needs.
- The development and retention of some employment sites in the inner area of the borough will require additional road infrastructure works to support the development and the local area.

1.6 Built environment

- Some of the borough's listed building stock is either underused or under threat from demolition; there are also 5 grade II* listed buildings classified as being 'at risk' on the national register and around 40 grade II listed buildings 'at risk' on the local register.
- A number of buildings and structures of local interest do not benefit from protection by national legislation (and currently do not benefit from identification under local policy).
- Some Conservation Areas are at risk due to poor maintenance, which may alter a locality's sense of place.

1.7 Retail and town centres

- In most centres the condition of some of the older commercial property stock is a cause for concern. Improvements are required to safeguard these properties.
- Some of the shopping centres are no longer suitable for modern commercial requirements. Remodelling or refurbishment will be required to meet future requirements.
- Leisure and cultural facilities such as restaurants, cinemas, theatres and performance venues are limited within the borough's town centres.

2. Social infrastructure

2.1 Health

- Suitable locations are needed for delivering additional primary and community healthcare facilities. Ashton and Scholes, Wigan are the next priorities for strategic estate development but due to the NHS Trust's current financial uncertainty neither of these schemes are currently being progressed.
- Access to accident and emergency facilities is difficult for many residents, particularly in the south-east of the borough.

2.2 Education

- A number of primary and secondary schools in the borough are in poor condition and are in need of modernisation.
- There are a number of schools in the borough with a significant surplus of school places. These include PEMBEC, Hesketh Fletcher, Nicol Mere and Bickershaw CE. Overall, the borough has an 8% surplus of primary places

and 7.7% surplus of secondary places. There are also schools with significant levels of overcrowding.

- The projected increase in population and the level of proposed new housing, both within the proposed broad locations and elsewhere, is likely to result in the need for new school provision in the borough. This could be the expansion of existing schools or new schools.
- The rate of growth of the borough's colleges is raising locational and transport issues.
- Wigan and Leigh College's objectives include the provision for a focal point for Higher Education in Wigan and to increase the skills offer in Leigh to accommodate vocational and adult provision. The College however aims to reduce the size of its overall estate.

2.3 Emergency services

• There is a requirement in the future to improve facilities and capacity of the borough command at the Wigan fire station when funding resources become available.

2.4 Leisure and culture

• There is a limited range of cultural facilities in the borough such as theatres and performance venues.

2.5 Communities

- There is a need for more accessible community facilities in some parts of the borough.
- The level of proposed new housing, both within the proposed broad locations and elsewhere, is likely to result in the need for additional community provision.

2.6 Affordable housing

- The affordable housing sought by moving households in the borough represents a demand for 3,307 units. Of this total, 2,073 are implied for council rented accommodation, 940 for Housing Association rented, and 294 for shared ownership.
- 1,231 concealed households are also looking for social housing. Nearly half of this is for one bed accommodation, with over a third seeking 2 bed accommodation.
- The greatest requirement for affordable housing occurs in the outer areas of the borough including Orrell, Billinge, Winstanley, Shevington, Standish and Aspull. These areas account for almost half of the affordable housing requirement from moving households.
- The 2008 Wigan Housing Needs and Demand Study indicates that the total level of outstanding affordable housing need is for 277 units per annum, after allowing for current re-let supply.

3. Green infrastructure

3.1 Open space and recreation

- There are catchment gaps for play provision throughout the borough.
- Allotments are in short supply, with demand for plots outstripping supply by two to one.
- Half of the people in the borough live within a short walking distance of countryside and open land but, although convenient for many, it is underutilised for informal recreation.

3.2 Wildlife and habitats

- Greenheart will be critical to the borough's Green Infrastructure and adaptation to climate change. A key component of this will be ensuring that wildlife habitats and species are part of linked networks.
- New development needs to address the continuity of wildlife habitats through careful design and enhancement on-site linking into surrounding habitats.
- There is a need to improve public accessibility to areas of countryside and wildlife habitat whilst conserving and protecting habitats.

- 0 to 5 years: 2011 to 2016 completed projects
- 0 to 5 years: 2011 to 2016
- 6 to 10 years: 2016 to 2021
- 11 to 15 years: 2021 to 2026

2. It draws on information from within the council and from key stakeholders and partners on infrastructure projects committed or anticipated to meet the spatial objectives and growth anticipated in the Wigan Local Plan Core Strategy.

3. The Schedule sets out information by:

- **Category**: based on the categories set out in the Infrastructure Types Table in the Introduction
- **Project:** brief description
- Where? (location): the town or area of town within the borough
- When? (timescale): estimate of year(s) of project to completion
- Who? The lead and other delivery partners
- How? (funding mechanism): the main funding for the project
- **Cost:** in £ thousands
- **Notes:** further description or other relevant information
- **Policies:** the relevant Core Strategy policies
- **Status:** Completed, Committed, Planned (but funding or permissions still to be confirmed) or Long Term / Aspiration
