Unitary Development Plan: Status of Policies September 11th, 2013

Many of the policies of the UDP have now been replaced by Core Strategy policies and therefore no longer remain part of the development plan. Others have been replaced by the policies of the GM Waste or Mineral plans, whilst 3 policies, EM1F, R1 and R1A, were not 'saved' and no longer apply.

The UDP policies which remain in force should, in many cases, be treated with care as the weight that can be given to them will be limited where they are inconsistent with the provisions of the National Planning Policy Framework.

The table below lists all the former UDP policies and describes their current status and, where they have been replaced, specifies which policy or policies replace them.
