2. Nomination papers must be delivered to the Returning Officer, TOWN HALL, LIBRARY STREET, WIGAN, WN1 1YN on any day after the date of this notice but no later than 4pm on Tuesday, 5th April 2022.
3. If any election is contested the poll will take place on Thursday, 5th May 2022.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Thursday 14 April 2022. Applications can be made online: <https://www.gov.uk/register-to-vote>
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at TOWN HALL, LIBRARY STREET, WIGAN, WN1 1YN by 5 pm on Tuesday, 19th April 2022.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at TOWN HALL, LIBRARY STREET, WIGAN, WN1 1YN by 5 pm on Tuesday, 26th April 2022.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at TOWN HALL, LIBRARY STREET, WIGAN, WN1 1YN by 5pm on Thursday, 5th May 2022. The physical incapacity must have occurred after 5pm on Tuesday, 26th April 2022. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday, 26th April 2022
