Electors and their proxies should take note that new applications to vote by post, amendments to or cancellation of existing applications to vote by post, or by proxy, must reach the Electoral Registration Officer at the Elections Office, the Town Hall, Library Street, Wigan WN1 1YN by 5pm on Tuesday, 26<sup>th</sup> November 2019.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at the Elections Office, the Town Hall, Library Street, Wigan, WN1 1YN by 5pm on Wednesday, 4<sup>th</sup> December 2019.
- 9. Applications to vote by proxy on relevant emergency grounds (disability occurring after 5pm on Wednesday, 4<sup>th</sup> December 2019; grounds relating to the applicant's occupation, service or employment, where the applicant became aware of those grounds after 5pm on Wednesday, 4<sup>th</sup> December 2019; or detention under civil powers as a mental health patient) must reach the Electoral Registration Officer at the Elections Office, the Town Hall, Library Street, Wigan, WN1 1YN by 5pm on Thursday, 12th December 2019, if they are to be effective for the election.
