Ownership and Operation of the Systems

The CCTV systems that are located within the Borough continue to be owned and managed by Wigan Council with the Chief Executive Officer of the organisation being the Data Controller.

All the specially trained officers who carry out the operational monitoring of the CCTV systems are in house officers and are directly employed by the Council and no outside agencies or contractors are used to carry out these duties.

Policy Statement

This CCTV Code of Practice gives valuable guidance in the use of CCTV, and the protection of law-abiding citizens and where CCTV it is considered beneficial, it should always be used as part of a wider crime prevention strategy, not as a sole means, however, CCTV does play an important part in our fight against crime.

The CCTV observational system is owned and operated by Wigan Council and is in place to provide a safer environment for all those who live, work and visit the parts of the Borough that are covered by CCTV.

The CCTV system is operated in partnership with:-

- Greater Manchester Police (GMP)
- Retail Security Teams
- Pub Watch Groups
- Transport for Greater Manchester (TfGM)
- Greater Manchester Fire and Rescue Service
- Any other Group contributing to the Scheme

Together with our partners we will aim to:-

- Assist in the detection and prevention of crimes that are committed in areas covered by CCTV
- Wherever possible provide the necessary digital images as evidence to enable a successful prosecution in either the criminal or the civil courts
- Demonstrate that CCTV is a valuable weapon in the fight against crime and anti-social behaviour by acting as deterrent to those would-be offenders
- Increase public awareness of CCTV by publicising convictions
- Reduce the fear of crime amongst the general public
- Assist Local Authority Township and Partnership Groups to combat crime
- Provide assistance to the emergency services
- Assist in safeguarding of vulnerable adults and young persons
- Provide assistance to other Local Authority Departments
- Improve Traffic Management in areas covered by CCTV
- Tackle Environmental Crime

This CCTV system and its protocols, will at all times comply with National Legislation and any Statutory Acts that are in place to safeguard the use of CCTV for public space surveillance purposes, for example British Standards (BS) 7958:2015 and BS 7858: 2012. There will also be an annual independent audit of the system and protocols with any recommendations implemented at the earliest opportunity. In addition the CCTV system and its protocols will be subject to both the National Security Inspectorate and Surveillance Camera Commissioners annual audits.

Reviews of this CCTV Code of Practice will be undertaken periodically and when necessary be ratified by the appropriate Council committee. Purpose of the CCTV Systems

The use of Wigan Council's observational CCTV system remains the same and it shall be used for the purpose of:-

- Providing the Police and the Council with evidence to take criminal and civil action in the Courts;
- Reducing the fear of crime and providing reassurance to the public;
- Providing assistance in the prevention of crime;
- Assisting with the maintenance of public order;
- Deterring or reducing the incidence of vandalism, graffiti, and other environmental crime;
- Deterring persons from committing crimes and to enhance the opportunities for detecting those who do;
- Improving the safety and security of residents, visitors and the business community;
- Discouraging anti-social behaviour including alcohol and drug-related elements;
- Assisting aspects of Town Centre Management.

Wigan Council is committed to maintaining, reviewing, and enhancing the systems in order to ensure and improve their effectiveness, it is also committed to maintaining civil liberties.

Changes in scope of CCTV Systems

The basic principles and the scope of the CCTV system have remained the same since the first systems were installed and have continued over the years when any new system came on line, which is to provide a public space surveillance service to the areas of the Borough which are covered by a CCTV system.

Data Protection and Legal requirements

Information relating to our compliance to the current Data Protection Act, the General Data Protection Regulation (25th May 2018) and all other Legal requirements that are in force that govern the use of public space surveillance systems are contained within the CCTV Codes of Practice

Location of the CCTV Systems

During 2017 and in early 2018 there were additional public space surveillance cameras located in Pemberton, Winstanley and Shevington with Lower Ground added to Wigan Council's CCTV system. These new and existing sites are continuing to function under their original operational requirement remit, which is the prevention and detection of crime, reducing the fear of crime, provide a safer environment for all those who live, work and visit the parts of the Borough that are covered by CCTV.

The areas within the Borough that are currently covered by the CCTV systems are a mixture of town centres and residential/retail areas, the following are their locations;

Town Centre's

- Wigan, including Mesnes Park and Haigh Woodland Park
- Leigh
- Ashton-in-Makerfield, including Jubilee Park

- Atherton
- Golborne
- Tyldesley
- Hindley

Residential and Retail areas

- Scholes
- Smithy Green
- Norley Hall
- Borsdane
- Worsley Mesnes
- Marsh Green
- Worsley Hall
- Pemberton
- Winstanley (2018)
- Shevington with Lower Ground (2018)

The introduction of any new CCTV system or extension to an existing system is subject to a feasibility review, consultation with the relevant groups involved, and the appropriate levels of funding being made available.

Temporary CCTV Systems

Wigan Council do utilise temporary CCTV systems when there is the evidence to support the need and in locations where there is generally no permanent CCTV systems. The use of the system is undertaken in conjunction with Ward Councillors, other directorates within the Council and partner agencies, it is operated under the same regulations and guidelines as the permanent CCTV systems.

CCTV Monitoring Suite and 24/7 Contact Centre

The CCTV monitoring suite provides both the monitoring service for all the boroughs CCTV systems and the Council's 24/7 contact centre services. The officers who monitor the CCTV systems also carry out the duties relating to the Council's 24/7 contact centre service. These duties include monitoring alarm activated CCTV sites, receiving out of hours calls for the public of the Borough, providing a housing concierge service, emergency repairs service, civil contingency support, police airwave radio systems, pub/ shop watch radio systems monitoring and lone worker monitoring.

Statistical Information

The statistical information at appendices 1, 2 and 3 is for the full calendar year of 2017 and shows the comparison with the previous years of 2015 and 2016, it also combines activities of the two areas that are recorded, CCTV monitoring and the 24/7 contact centre.

Contracts with suppliers

Some of the services that we provide to our customers are undertaken by our approved contractors who have been selected through the recent corporate procurement process

conducted in 2017 and have been awarded a contract for a length of time between 3 to 5 years with options to extend that period.

Each contract is monitored and reviewed on an annual basis and, where applicable, if the option to extend a contract available and it is taken up then a variation of the original contract will be signed by all interested parties.

Maintenance and performance of CCTV system


All information and copies of the relevant documents which refer to the maintenance and performance of the CCTV system is contained within the CCTV & Risk Management Manuals (Internal document)




