Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways at the Rear of 46 to 100 Argyle Street, the Side of 29 Algernon Street and Rear of 25 to 43 St Andrews Crescent, Hindley.

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

THE WIGAN BOROUGH (PASSAGEWAYS AT THE REAR OF 46 TO 100 ARGYLE STREET, THE SIDE OF 29 ALGERNON STREET AND REAR OF 25 TO 43 ST ANDREWS CRESCENT, HINDLEY) GATING ORDER 2007

Wigan Borough Council in exercise of its powers under Section 129 of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Hindley hereby makes the following Order:-

- 1. This Order may be cited as the Wigan Borough (Passageways at the Rear of 46 to 100 Argyle Street, the Side of 29 Algernon Street and Rear of 25 to 43 St Andrews Crescent, Hindley) Gating Order 2007 and shall come into operation on
- 2. The public right of way along the following passages is restricted at all times:-

- (i) the Rear of 46 to 100 Argyle Street
- (ii) the Side of Algernon Street
- (iii) the Rear of 25 to 43 St Andrews Crescent
- 3. Nothing in article 2 of this Order shall apply to:
 - all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
 - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
 - c) persons using the highway for police, ambulance or fire brigade purposes
 - d) Council officers on business
 - e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council
- 4. There are no alternative routes in this instance
- 5. The maintenance and operation of the gate will be the responsibility of the Council
- 6. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
