THE WIGAN BOROUGH (PASSAGEWAYS TO THE REAR OF 15 TO 21 CHAPEL GREEN ROAD AND THE REAR OF 9 TO 27 BLANTYRE STREET, THE SIDE OF 27 BLANTYRE STREET AND THE REAR OF 1 TO 10 BAMBER COURT HINDLEY) GATING ORDER 2007

Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to the Rear of 15 to 21 Chapel Green Road and the Rear of 9 to 27 Blantyre Street, the Side of 27 Blantyre Street and the Rear of 1 to 10 Bamber Court Hindley

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN by quoting reference DLPS//BD/Q41/56-/Q-000876 by 19th December 2007. Please state the grounds on which they are made.
