GATING ORDER 2007**

Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to the rear of Wilkinson Street and side of Stringer Street, the rear of Cook Street and side of Stringer Street, the rear of Cook Street and side of Youd Street, the rear of Wilkinson Street and side of Youd Street, the rear of Cook Street and side of Youd Street and the rear of Cook Street and side of Boughey Street, Leigh.

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN quoting DLPS/VW/Q41/19-/Q-000791 by 5<sup>th</sup> October 2007. Please state the grounds on which they are made.

GATING ORDER 2007**

Wigan Borough Council in exercise of its powers under Section 129 of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Leigh hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Passageways to the rear of Wilkinson Street and side of Stringer Street, the rear of Cook Street and side of Stringer Street, the rear of Cook Street and side of Youd Street, the rear of Wilkinson Street and side of Youd Street, the rear of Cook Street and side of Youd Street and

the rear of Cook Street and side of Boughey Street, Leigh.) Gating Order 2007 and shall come into operation on

2. The public right of way along the following passages is restricted at all times:-

- i) Rear of 7 Wilkinson Street and side of 19 Stringer Street
- ii) Rear of 10 Cook Street and side of 1 Stringer Street
- iii) Rear of 22 Cook Street and side of 2 Youd Street
- iv) Rear of 19 Wilkinson Street and side of 20 Youd Street
- v) Rear of 21 Wilkinson Street and side of 23 Youd Street
- vi) Rear of 24 Cook Street and side of 1 Youd Street
- vii) Rear of 38 Cook Street and side of 2 Boughey Street
- viii) Side of 24 Boughey Street

3. Nothing in article 2 of this Order shall apply to:

- a) all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
- b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
- c) persons using the highway for police, ambulance or fire brigade purposes
- d) Council officers on business
- e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council

2. Alternative routes are available via Wilkinson Street, Youd Street, Boughey Street, Cook Street and Stringer Street, Leigh.

3. The maintenance and operation of the gate will be the responsibility of the Council.

4. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
