**THE WIGAN BOROUGH (PASSAGWAY KNOWN AS**  
**HARBURY WALK, WIGAN) GATING ORDER 2007**

Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageway known as Harbury Walk, Wigan.

Details of the exemptions are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN quoting reference DLPS/SYF/Q-772 by 17<sup>th</sup> August 2007. Please state the grounds on which it is made.

**(Proposed Gating Order)**  
**THE WIGAN BOROUGH (PASSAGWAY KNOWN AS**  
**HARBURY WALK, WIGAN) GATING ORDER 2007**

Wigan Borough Council in exercise of its powers under Section 129 of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Wigan hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Passageway Known as Harbury Walk, Wigan) Gating Order 2007 and shall come into operation on .
2. The public right of way along the passageway known as Harbury Walk, Wigan is restricted at all times.
3. Nothing in article 2 of this Order shall apply to:
  - a) all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
  - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near

the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984

- c) person using the highway for police, ambulance or fire brigade purposes
  - d) Council officers on business
  - e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council
4. Alternative routes are available via the pedestrian route adjacent to number 4 Harbury Walk.
  5. The maintenance and operation of the gate will be the responsibility of the Alleygating Co-ordinator
  6. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
