THE WIGAN BOROUGH (PASSAGEWAYS TO THE REAR OF 98–118 SWINLEY ROAD, 4-24 HORNBY STREET, 9-15 KENYON ROAD AND TO THE SIDE OF 2 EDWARD STREET, WIGAN) GATING ORDER 2012

Wigan Borough Council in exercise of its powers under Section 129A of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Wigan hereby makes the following Order:-

- This Order may be cited as the Wigan Borough (Passageways to the rear of 98-118 Swinley Road, 4-24 Hornby Street, 9-15 Kenyon Road and to the side of 2 Edward Street, Wigan) Gating Order 2012 and shall come into operation on Sunday 1st July 2012.
- 2. The public right of way along the following passages as shown for identification purposes only on the attached plan is restricted at all times:-
 - (i) Passageway to the rear of 98-118 Swinley Road
 - (ii) Passageway to the rear of 4-24 Hornby Street
 - (iii) Passageway to the rear of 9-15 Kenyon Road
 - (iv) Passageway to the side of 2 Edward Street
- 3. Nothing in article 2 of this Order shall apply to:
 - a) all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
 - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
 - c) persons using the highway for police, ambulance or fire brigade purposes
 - d) Council officers on business
 - e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council
- 4. Alternative routes are available via Hornby Street, Edward Street, Swinley Road and Kenyon Road.

- 5. Gates will be installed at the approximate locations marked on the attached plan and each will be operated and maintained by the Council.
- 6. The maintenance and operation of the gate will be the responsibility of the Council's Anti-Social Behaviour Co-ordinator who may be contacted at Places Directorate, Neighbourhoods Teams, Wigan Council, PO BOX 100, Wigan WN1 3DS.
- 7. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
