Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to the side of 2 Rydal Street, the rear of 68 Twist Lane, the side of 58 Wilkinson Street, the rear of 54 Twist Lane, the rear of 40 Wilkinson Street and the rear of 22 Rydal Street Leigh.

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN quoting reference DLPS/BD/ Q41/37-/Q-000855 by 23 November 2007. Please state the grounds on which they are made.

THE WIGAN BOROUGH (PASSAGEWAYS TO THE SIDE OF 2 RYDAL STREET AND THE REAR OF 68 TWIST LANE, THE SIDE OF 58 WILKINSON STREET AND REAR OF 54 TWIST LANE, THE REAR OF 40 WILKINSON STREET AND REAR OF 22 RYDAL STREET LEIGH) GATING ORDER 2007

Wigan Borough Council in exercise of its powers under Section 129 of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Leigh hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Passageways to the side of 2 Rydal Street, the rear of 68 Twist Lane, the side of 58 Wilkinson Street, the

rear of 54 Twist Lane, the rear of 40 Wilkinson Street and the rear of 22 Rydal street Leigh) Gating Order 2007 and shall come into operation on

- 2. The public right of way along the following passages is restricted at all times:-
 - (I) The side of 2 Rydal Street and rear of 68 Twist Lane.
 - (II) The side of 58 Wilkinson Street and rear of 54 Twist Lane.
 - (III) The rear of 40 Wilkinson Street and rear of 22 Rydal Street
- 3. Nothing in article 2 of this Order shall apply to:
 - all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
 - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
 - c) persons using the highway for police, ambulance or fire brigade purposes
 - d) Council officers on business
 - e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council
- 4. Alternative routes are available via Rydal Street, Twist Lane and Wilkinson Street.
- 5. The maintenance and operation of the gate will be the responsibility of the Council
- 6. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
