Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the passageways to the rear of Maple Crescent, Briar Grove, Westbourne Avenue, Heather Grove and Westleigh Lane, Leigh.

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

Any representations or objections to the Order must be in writing to the Director of Legal and Property Services, Town Hall, Library Street, Wigan WN1 1YN quoting reference DLPS/SYF/Q-743 by 27th July 2007. Please state the grounds on which it is made.

(Proposed Gating Order) THE WIGAN BOROUGH (PASSAGEWAYS TO THE REAR OF MAPLE CRESCENT, BRIAR GROVE, WESTBOURNE AVENUE, HEATHER GROVE, WESTLEIGH LANE, LEIGH) GATING ORDER 2007

Wigan Borough Council in exercise of its powers under Section 129 of the Highways Act 1980 and all the enabling powers being satisfied that a Gating Order would be beneficial for tackling crime and anti-social behaviour to that area of Leigh hereby makes the following Order:-

- 1. This Order may be cited as the Wigan Borough (Passageways to the Rear Maple Crescent, Briar Grove, Westbourne Avenue, Heather Grove, Westleigh Lane, Leigh) Gating Order 2007 and shall come into operation on
- 2. The public right of way along the following passages is restricted at all times:-

- i) to the rear of 47 to 77 Briar Grove; and to the rear of 35 to 63 Maple Crescent; and between 39 and 41 Maple Crescent
- ii) to the rear of 1 to 45 Briar Grove; and to the rear of 65 to 109 Maple Crescent
- to the rear of 186 to 200 Westleigh Lane; and to the rear of 2 to 26 iii) Heather Grove; and to the rear of 1 to 37 Westbourne Lane; and adjacent to 26 Heather Grove; and adjacent to 37 Westbourne Avenue
- 3. Nothing in article 2 of this Order shall apply to:
 - all owners and occupiers of premises adjacent to or adjoining the a) passageways listed in Article 2
 - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
 - persons using the highway for police, ambulance or fire brigade purposes c)
 - d) Council officers on business
 - persons using the highway with the permission or at the direction of the e) duly authorised officer of the Council
- 4. Alternative routes are available via Briar Grove, Maple Crescent, Myrtle Avenue, Westbourne Avenue, Heather Grove and Westleigh Lane.
- 5. The maintenance and operation of the gate will be the responsibility of the Alleygating Co-ordinator
- 6. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
