Notice is hereby given that the Wigan Borough Council intends to make the above Gating Order under Section 129 of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers

The effect of the Order will be to restrict at all times, subject to certain exemptions, the public right of way over the following passageways:

To the rear of 134 to 146 The Avenue Between 121 to 151 Charles Street and 120 to 152 Bold Street To the rear of 90 to 112 Holden Road

Details of the exemptions and alternative routes along with full particulars of the passageways affected are set out in the proposed Order shown in the Schedule.

 This Order may be cited as the Wigan Borough (Passageways At The Avenue, Charles Street, Bold Street and Holden Road, Leigh) Gating Order 2007 and shall come into operation on

- 2. The public right of way along the following passages is restricted at all times:
 - i) Passageway to the rear of 134 to 146 The Avenue
 - ii) Between 121 to 151 Charles Street and 120 to 152 Bold Street
 - iii) To the rear of 90 to 112 Holden Road, Leigh
- 3. Nothing in article 2 of this Order shall apply to:
 - all owners and occupiers of premises adjacent to or adjoining the passageways listed in Article 2
 - b) persons using the highway in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any other telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984
 - c) persons using the highway for police, ambulance or fire brigade purposes
 - d) Council officers on business
 - e) persons using the highway with the permission or at the direction of the duly authorised officer of the Council
- 3. Alternative routes are available via the pavements of The Avenue, Charles Street, Bold Street and Holden Road.
- 4. The maintenance and operation of the gates will be the responsibility of the Council.
- 5. The conditions set out in Section 129A (3) of the Highways Act 1980 have been complied with for the purposes of making the Order
