Dear parent or guardian

This booklet tells you how to apply for a place for your child at a reception class for the next school year, beginning in September 2011. I know this is an important time for you and your child and we want to help you as much as we can.

This booklet has a lot of information to help you apply. You should take the time to read **all** the information carefully before you apply, even if you have already decided which schools you prefer.

We will try to give you your preferred school, but schools only have so many places available. If we receive more applications than places, we use the admission criteria to decide who will get a place. The admission numbers and admission criteria for Wigan schools are given in this booklet.

Our website at www.wigan.gov.uk has a link to school admissions and other useful sites. You can use this site to apply for a primary school place online. You can find more details about this in the booklet.

Each school also produces its own prospectus which has a lot of information about that school. If you want any information about individual schools, please contact the headteacher at the school, who will be pleased to help.

Our School Places Team can help you with any questions you have about school admissions. You can contact the team on 01942 486040, 01942 486037, 01942 486038 or 01942 486039.

Please make sure you apply online or fill in and return the application form by the closing date, 15 January 2011. If you do not apply on time, you are less likely to get a place at the school you want.

Dear parents

Wigan Admission Forum

The current Wigan Admission Forum started in 2003. The forum includes Wigan Council representatives, head teachers, diocesan board representatives, parent governor representatives, people from the local community and local employers.

The Wigan Admission Forum reviewed the admission arrangements for 2011 for all schools in the Wigan area. We feel that these arrangements meet the requirements of the Admissions Code 2010.

In 2008, the 'equal preference' system of deciding on primary school places was introduced across the country. This system makes sure that, if you don't get your first-choice school, you still have a fair chance of being offered a place at your second- or third-choice school. There is more information about the equal-preference system on page 16.

You should choose three schools on your application form. This will give you the best chance of getting a place at one of your preferred schools. 97% of parents who applied for a place at Wigan schools in 2010 were offered a place at one of their preferred schools.

Other local authorities

If you live in another local authority, your application will be dealt with by your home authority. This is the local authority that collects your council tax. This applies whether you want a school in your home authority or in Wigan. You should contact your home authority's school admissions service for information about how to apply.

If you live outside Wigan, we will consider your application as being on time if it has been received by the closing date set by your home local authority. We will consider your request for a place at a Wigan school as long as you have put a Wigan school down as a first, second or third preference.

If any of your preferences are for a Wigan voluntary-aided (church) school we **strongly advise** you to fill in the school's own information form as well as your home local authority application form. If you do not fill in the school's own supplementary information form, the school will not have all the information they need to consider your application against their faith criteria and your child may not be given a place.

You can get a copy of the school's own supplementary information form:

- from the school;
- by calling the Wigan School Places Team on 01942 486037; or
- by downloading one from our website.

Please return filled-in information forms for Wigan schools to the individual school.

Applying online

You might want to apply online for your child's place at primary school because:

- it is quick and safe;
- we will confirm we have received your application;
- you can change your application at any time up until the closing date for applications (15 January 2011);
- there are clear, simple instructions to help you make your application; and
- the service is available 24 hours a day, seven days a week during the application period from November 2010 to 15 January 2011.

What do I need to apply online?

You need:

- · a computer with internet access; and
- an e-mail account.

I don't have a computer at home. How do I apply online?

If you don't have access to the internet at home, you can apply online at:

- an internet cafe; or
- a library (you should book a computer beforehand).

Timetable for applying for a place at primary school

On the next few pages, we have set out when each stage of the application process will take place and what you need to do.

Before November 2010

If you live in Wigan you can register your interest at any Wigan primary school. The school will record your details. This is so that the school can send you information about how to apply and is not an application for a school place.

November 2010

You will receive an application pack.

The primary school where you have registered an interest will send you:

- a copy of this booklet; and
- the Wigan Council primary school application form.

From November 2010 to 15 January 2011

You need to decide which schools you want to apply for and in what order.

Please read this booklet carefully because it:

- explains how we decide which school to offer your child; and
- gives information to help you decide if you are likely to get a place at a particular school.

You can get a school prospectus (a booklet with information about the school) from the schools. You can visit schools' websites on www.wiganschoolsonline.net.

How to apply for a primary school place

If you live in Wigan you must apply by filling in the **Wigan Council primary school application form** or **by applying online**. The application form and the online application service let you name your first, second and third preference of school. Your preferences can include schools in Wigan and schools in other local authorities. You will only be considered for the schools you put down on the form.

You might have filled in a form at a school when you told them you were interested in sending your child there, but that is not an application and will not count when we decide who to give places to.

Preferences for voluntary-aided (church) schools and supplementary information forms

Catholic schools

Wigan residents

If you live in Wigan and one of the schools you want your child to go to is a Wigan voluntary-aided Catholic primary school, you need to fill in the relevant section of the Wigan Council primary school application form. We will pass on the information to the school governors. If you do not fill in this part of the form the school will not have all the information they need to consider your application against their faith criteria and your child may not be given a place. If you apply online you need to complete the school's own supplementary information form and return it to the school. You can get a copy from our website or from the school.

Some Catholic schools ask you to show proof of baptism. The school will ask to see this if your child is offered a place. Please do not send any proofs of baptism to your local authority.

If any of the schools you want is a Catholic school in another local authority please contact the school to find out if they have any supplementary information forms you need to fill in.

Other local authority residents

If you live in another local authority and any of the schools you want to go to is a Wigan voluntary-aided Catholic primary school, you should fill in their supplementary information form and then return it to them.

Other voluntary-aided schools

If any of the schools you want your child to go to is a voluntary-aided (church) school other than a Wigan Catholic primary school, you should fill in their supplementary information form **as well as the Wigan Council primary school application form**. If you do not fill in the school's own form, they will not have all the information they need to consider your application against their faith criteria and your child may not be given a place.

You can get a copy of the supplementary information form:

- from the school:
- by phoning the School Places Team on 01942 486037; or
- by downloading one from our website.

If you name a voluntary-aided (church) school as one of your preferences and you do not fill in their supplementary information form, the school will not have all the information they need to consider your application and your child may not be given a place.

All filled-in voluntary-aided (church) school supplementary information forms must be returned to the school by the closing date of 15 January 2011.

Returning your Wigan Council primary school application form

You can hand in your form at any Wigan primary school.

You will be given a receipt for your application. You will need to keep the receipt until you get a letter telling you that your child has a place at a school.

Applying online

You will receive an e-mail letting you know your application has been received. The e-mail will also show your preferences. You will need to keep the e-mail until you get a letter telling you that your child has a place at a school.

If you have filled in any supplementary information forms you should return them to the school.

15 January 2011

15 January 2011 is the closing date for applications. We will only consider applications we receive by the closing date as on-time applications.

February to April

Your application will be processed.

26 April 2011

We will write to tell you the school we are offering your child. We will send the letter to you by first-class post and we will include a reply slip that you need to return to the school by 11 May 2011 to accept the place offered. If you don't send it back by that date the place may be withdrawn and it may be offered to another child.

Applying for a place at junior school

Some schools are for infant (reception, year one and year two) children only and you will need to apply for a place at junior school.

If you have a child in year two at infant school, in November you will get an admission to primary school booklet and a Wigan Council junior school application form.

You should apply in the same way as described above and hand in your Wigan Council junior school application form at your child's infant school by the closing date of **15 January 2011**.

If any of the schools you want is a voluntary-aided (church) school, you should fill in the school's supplementary information form as well as the Wigan Council primary school application form and return it to the individual school.

If you put a voluntary-aided (church) school as one of your preferences and you do not fill in their supplementary information form, the school will not have all the information they need to consider your application and your child may not be given a place.

We will decide on places in the same way we decide applications to reception class. See 'Important information about how we decide which school to offer your child' on page 13.

Late applications

You need to return your application form or apply online before 15 January 2011.

You must apply even if your child goes to a school nursery or has an older brother or sister at a school.

If your application is late, we will only look at it after we have looked at all the applications we received on time. This means that your child is far less likely to get a place at the school you want if your application is late. In 2010, 90% of available places were given to children whose parents applied by the closing date.

If you apply late, we may not write to you by 26 April 2011. However, we will write to you as soon as we can after that.

If you have not been able to apply for a school place by the closing date or even after school places have been offered, please contact The School Places Team, who will be able to help you.

Children going to nursery classes

If your child goes to a nursery class attached to a school:

 they do not have an automatic right to a place in a reception class at that school;

and

 you still need to send in your Wigan Council primary school application form or apply online by the closing date of 15 January 2011.

If there are more applications than places, we will use the admission criteria to decide who we give a place to.

The admission criteria for schools are different from those for nurseries.

Your child's home address

Many schools use the child's address when deciding who to offer places to.

You must give the correct permanent home address. This is where the child and parent, or the person who has care of the child or parental responsibility, normally live.

If you are separated and your child spends time at each parent's address, the address we use for admission to school is that of the main carer. We use the address of the parent who gets the Child Benefit for this.

We carry out checks to make sure addresses are genuine.

If we can't confirm your address, or any issues are raised about your address, we may carry out further checks.

We may ask to see two forms of proof of your permanent address at the closing date for applications (we will accept photocopies). This may include:

- proof of where you are registered for council tax;
- your television licence;
- your wage or salary slip; or
- proof of your child tax credits.

Any proof you provide must show that the parent or main carer lives at this address at the closing date for applications.

If your address temporarily changes (for example, if you go to live with a relative), you cannot use this temporary address.

When we consider your child's application, we use the permanent home address we have for you at the closing date for applications.

If you move house after the closing date for applications (but before we send allocation letters to parents) you must write to tell the School Places Team. We cannot use this address to consider your application from but will make sure we write to you at the correct address.

False information

If you give any false information to get a school place (for example, if you give the wrong permanent address at the closing date for applications), we may withdraw the offer and your child may lose their place. Last year a number of people gave us false information and their places were withdrawn.

If you think someone has given false information to get a school place, please contact the School Places Team.

Delaying entry to primary school

By law, your child does not have to start school until the admission date after their fifth birthday. The admission dates set by the Government are:

- 31 August;
- 31 December; and
- 31 March.

You can ask to delay the date your child starts primary school until later in the school year or until your child reaches compulsory school age (the age they must, by law, start school) in that school year. If you delay entry, we will hold the place open and not offer it to another child. You cannot delay entry beyond the beginning of the term after your child's fifth birthday, or until after the school year for which you originally applied.

If you want to delay entry beyond the 2011 school year we cannot guarantee that there will be a place at the school you want.

Attending part-time

You can ask for your child to attend part-time until they reach compulsory school age.

Types of primary school in Wigan

In Wigan there are two types of primary school. Each type of school has an admission authority that considers applications.

Community and voluntary-controlled schools

Wigan Council is the admission authority for community and voluntary-controlled schools and we decide who will be offered places if there are more applications than the number of places available. The admission criteria for community- and voluntary-controlled schools are given on pages 32 to 46 of this booklet.

Voluntary-aided (church) schools

The governing bodies of voluntary-aided schools decide who will be offered a place if there are more applications than places. You can find the admission criteria for Wigan voluntary-aided schools on pages 47 to 171.

The admission criteria for voluntary-aided primary schools usually take account of church membership, church attendance or both. They ask for information about this on their supplementary information form.

If you want a place at a voluntary-aided Catholic primary school, we strongly advise you to fill in the relevant part of the Wigan Council primary school application form.

If you want a place at a voluntary-aided school that is other than Catholic, you should:

- get the school's supplementary information form; and
- send it back to the school by the closing date of 15 January 2011.

You should fill in the school's supplementary information form as well as the Wigan Council primary school application form for each voluntary-aided school you name, whether it is your first, second or third preference.

Schools in other local authorities

If you live in Wigan and you want to apply for a place at a school in another local authority area, you can name the school as one of your preferences on your Wigan Council primary school application form or online application. If you want information about a school in another local authority, please contact the authority's school admissions service or the school. If one of the schools you want your child to go to is a voluntary-aided (church) school, please contact the school to find out if they use an supplementary information form.

Associated secondary schools

Some Wigan secondary schools currently have children who live in particular postcodes, and also go to named primary schools at the time of application, as 'criterion 3' in their admission arrangements.

How we decide which school to offer your child

We will consider the following things when we decide which school to offer your child a place at.

- The three schools you name on the application form.
- The admission number for each school.
- The admission criteria for each school.
- The priority you have given schools on your application.

When we consider applications we have received on time, we will only use correct information on your application form at the closing date for applications.

Giving preferences for school places

By law, we must use the equal-preference system when we decide on school places. This system makes sure that, if you don't get your first-preference school, you still have a fair chance of being offered a place at your second- or third-preference school. This is why you need to give three preferences. We explain how the system works on page 16.

When you decide your preferences, you need to be realistic about your child's chances of getting a place. The information in this booklet will help you to do this. If you need more advice, please phone the School Places Team on 01942 486039.

Admission number

Every school has an admission number – this is the number of places in a school year group. The admission numbers for all Wigan primary schools are given with the information on each school in pages 32 to 171 in this booklet.

Admission criteria

When there are more applications than there are places available for a school, we say the school is 'oversubscribed'.

If we receive more applications than there are places available, we use a fixed set of rules to decide which children we offer a place to. We call these rules the 'admission criteria'.

The admission criteria for all Wigan primary schools are given in pages 32 to 171 of this booklet. You will see that the criteria have different numbers. Children in criterion group one will have first priority for places, children in group two will be considered next and so on until all available places have been allocated.

Tie-breaker

When we use the admission criteria, more children might fall into a category than the number of places available. If this happens, we use a 'tie-breaker' to decide who we give a place to.

At community and voluntary-controlled schools, we will give places to the children who live nearest to the school. We measure this distance:

- in a straight line; and
- using a Geographical Information System (GIS) which is based on Ordnance Survey maps.

We will measure from your child's home address to a central point on the school site. If you want more information about where we measure to at community or voluntary-controlled schools, please contact the School Places Team.

If we offer the last place available at a school to one of twins (or triplets, and so on), our policy is to accept the other twin or triplets. However, we cannot do this if it would mean class sizes go above the legal limit. If this happens, we will offer the place that is available and you can decide which child will take up the place. We will also tell you which other schools could take all the children.

Sometimes, the distance from home to school is the same for more than one child (for example, if more than one child lives in the same block of flats). In these cases, we will use a system to randomly pick who will be offered the place. If you want more information on this, please phone the School Places Team on 01942 486039.

The tie-breakers for voluntary-aided schools are given with the admission criteria for each school on pages 47 to 171 of this booklet.

Children in public care (looked-after children)

If you are responsible for a child in public care, please let us know on your application.

Brothers and sisters

The admission criteria for community and voluntary-controlled schools mean that children who have brothers or sisters at the school when they start are put in criterion two.

We will include:

- half-brothers and half-sisters;
- stepbrothers and stepsisters; and
- foster brothers and foster sisters;

who live at the same address as part of the same family unit.

Voluntary-aided (church) schools

You should remember that some voluntary-aided primary schools may have different requirements than Wigan Council has. You should check each school's admission arrangements for details.

If you want more information about each school's admission policy, such as waiting lists or the right to appeal, you should contact the school.

If your child goes to a voluntary-aided school nursery, they are not guaranteed a place at the primary school. You should read the admission criteria carefully.

Children with a statement of special educational needs

Children with a statement of special educational needs that names a school will be offered a place at that school. This applies to all types of school.

The 'equal preference' system and the priority order of schools on your application

By law, we must use the equal-preference system when we consider your application for a school place.

We offer places by doing the following.

- First, we rank all first-, second- and third-preference applications by using the school's admission criteria. This means that some second- and thirdpreference applications will be ranked higher than some first-preference applications.
- We use schools' admission numbers to find out how many children can be offered a place at each school.
- We then offer places to all children whose first preference can be met, and remove their second and third preferences from the list.
- We do this again for second preferences and then third preferences.

This means that if you miss out on your first-preference school, you still have a fair chance of being offered a place at your second- or third-preference school.

Voluntary-aided (church) schools

The governors of voluntary-aided (church) schools rank applications using their admission criteria. The ranks are then given to the School Places Team who co-ordinate the offer of a single place in the same way as described above.

Waiting lists

Places may become available at a school after the offer date of 26 April 2011. All admission authorities must run a waiting list until the end of the autumn term 2011.

For community and voluntary-controlled schools, we will:

- put all children we refuse a place at one of their preferences on the waiting list for that school;
- keep the list in priority order (this order is decided by the admission criteria for the school only);
- offer any places that become available to the next child on the waiting list; and
- keep the waiting list open until the end of the autumn term 2011.

Important information about the waiting list

We cannot consider how long your child's name has been on the waiting list, only the admission criteria for the school. This means that your child's position on the list may change if another parent asks to be put on the list and their child has higher priority in the admissions criteria.

If you tell us, after the closing date for applications, that your address has changed and you provide documents to prove this, we will take that into account.

If you no longer want your child's name to be on a waiting list, please let us know by letter or e-mail.

Waiting lists for voluntary-aided (church) schools

Each voluntary-aided school has details of their waiting list policy in their admission arrangements. The governing body of the school is responsible for the waiting list. If you are refused a place at a voluntary-aided school, you should contact the school to make sure your child's name is on the waiting list.

Giving a place from a waiting list

If a place becomes available at an oversubscribed school and your child's name is at the top of the waiting list, we will phone you to ask if you want to accept the place. We will then send you a letter to confirm the new offer. The letter will include a reply slip which you need to return to the school by the date given. If you do not return the slip by this date, the place may be withdrawn and offered to another child.

If you accept an offer of a place from a waiting list we will withdraw any other place we have already offered and make it available for another child.

Important questions answered

When will my child start primary school?

In Wigan, if your child will turn five between 1 September 2011 and 31 August 2012, they will start primary school in the reception class at the start of the new school year in September 2011.

Can I delay my child's admission?

Yes – see page 10 for more details.

Can my child attend part-time?

Yes – see page 10 for more details.

Who will deal with my application?

If you live in Wigan your application will be dealt with by the Wigan School Places Team. If you live in another local authority you must apply to that authority. See pages 1 - 2 for more details and phone numbers for other authorities near us.

Do I have to put three school preferences on my application?

You should give three preferences. If you do not:

- it does not mean you have more chance of getting a place at your first-preference school; and
- we do not know which other schools you are interested in. If we cannot offer you
 your first-preference school, we could only offer the nearest school to your child's
 home with a spare place. You may miss out on a place at another school you
 may have preferred.

Also, repeating the name of one school three times on your application does not improve your chances of getting a place there.

Can I apply for a place at a school in a different local authority?

If you live in Wigan you can apply for schools in any local authority. Other local authorities produce their own admission booklets with details of their schools, and will be pleased to send you a copy. There is a list of our neighbouring local authorities, with contact details, on page 2 of this booklet.

If your child lives in Wigan and you want to apply for a place at a school in another local authority, you can apply using our online application service or:

- fill in the Wigan Council primary school application form we sent with this booklet;
- put the name of the other local-authority school on the application form; and

• return the application form to any Wigan primary school by the closing date, 15 January 2011.

However you apply, we will deal with the other local authority on your behalf.

Please make sure you fill in and return any supplementary information forms for voluntary-aided schools in other local authorities, as well as the filled-in Wigan Council primary school application form or online application.

I do not live in Wigan. Can I apply for a place at a Wigan school for my child?

Anyone can apply for a place in a Wigan school. However, you should look at the admission criteria to see if you have a reasonable chance of getting a place.

Your own local authority will provide you with their application pack. If you want a place at a Wigan school:

- put the name of the school on your own local authority's primary school application form; and
- apply to your own local authority by the closing date.

Your local authority will deal with us on your behalf.

If any of your preferences is for a Wigan voluntary-aided (church) school, please get a copy of their supplementary information form and return it to the school. You can get a copy from our website at www.wigan.gov.uk or from the school.

Who decides if my child is given a place?

Wigan Council decide which children will be offered places at community and voluntary-controlled primary schools in Wigan. These schools are listed on pages 32 to 4 in this booklet.

The governors of the school decide which children will be offered places at Wigan voluntary-aided (church) primary schools. These schools are listed on pages 47 to 171 in this booklet.

If any of your preferences is for a school in another local authority, that local authority will consider your application and let us know if your child is given a place.

Can I change my mind after I have sent my application?

Changing your mind up to the closing date

If you change your mind about your preferences or order of schools you have put on the application form, you must write to the School Places Team before the closing date (15 January 2011) to give them the details.

If you apply online, you can change your preferences at any time up to the closing date by changing them on your online application form. You must follow the instructions given on the website to make sure your preferences have been changed.

Changing your mind after the closing date (15 January 2011)

If, after the closing date, you change your mind about your preferences or the order of your preferences, you must send a letter or e-mail to the School Places Team. However, we will treat this as a late application (see page 8) and it may reduce your chances of getting a place at the school you want.

What happens if you cannot offer a place at any of the schools I have asked for?

If your child lives in Wigan, we will offer a place at the nearest Wigan school to your home address that has a spare place. This will be the nearest community, voluntary-controlled or voluntary-aided school.

If your child does not live in Wigan, the local authority in your area will offer them a place. (This is the authority that charges council tax for the child's home address.)

You are assessing my child for a statement of special educational needs. Or, my child has a statement of special educational needs. How do I apply for a place at a primary school?

You should register your interest at a primary school. You will receive an application form and you should apply in the normal way.

You must return the form or apply online by the closing date of 15 January 2011.

You should still apply even if your child is being considered for a place at a special school. This is so you have a better chance of getting a place at the school you prefer if your child does not need a specialist place.

Before your child starts school, your Early Years Inclusion Worker will speak to you about your child's education. If your child needs a specialist place, we will tell you about the possibilities and discuss it fully with you and the professionals who know your child best before we make any decisions.

Why do you give information about admissions to schools from last year?

We give details of how we offered places last year to help explain how we decided on the available places. You may want to use this information as a guide to whether you are likely to get a place at one of your preferred schools. However, the information is only a guide because the number of applications for a school is different each year.

Admission appeals

You can appeal to an independent appeal panel if Wigan Council or the school governing body refuse a place at any school you have applied for.

If we refuse your child a place at a school, we will write to tell you:

- why we refused;
- how to appeal;
- the time limit for sending your appeal (you will have at least 14 days from the date of the letter);
- where to send the appeal; and
- who to contact if you need any help.

Sometimes, places become available at a school before the admission appeals have been heard. If this happens, we will offer places to the next child on the waiting list. If you appeal, it does not affect your child's place on the waiting list.

Before you decide if you want to appeal, you will probably want to think about:

- the school's admissions criteria for admitting pupils;
- why you want your child to go to the school;
- which school your child wants to go to; and
- how strong a case you have.

You may also want to visit the school your child has been offered a place at.

The appeal hearing

Before the hearing

We will tell you the date, time and place of the hearing 10 school days before it takes place.

Seven days before the hearing, the local authority or the school will send you a document called the 'Statement of case'. This sets out the reasons why your child was not offered a place. The appeal panel will also get a copy of this.

The panel also receives all the documents you sent in to support your child's appeal. If you have any more information or supporting documents that you want the panel to consider, you should supply these as soon as possible as this will help the panel to run smoothly and avoid delays. We would appreciate it if you could provide eight copies of any extra paperwork.

The appeal panel

The panel will have three or five people on it. They are completely independent of us and the school you are appealing for. There will also be a clerk to the appeal panel.

At the appeal hearing

You should go to the appeal hearing if you can. You will not usually need legal representation but you can bring a legal adviser or a friend along for support.

There will be a Wigan Council or school representative at the hearing to give their reasons for refusing your child a place and you can ask them questions about this. You will be able to put your case for your child to the panel. You will probably want to give the original reasons you applied for that school.

If you cannot go to the appeal hearing, the panel will consider all the information you have sent in writing.

At the end of the hearing, the clerk should be able to tell you when you can expect to receive the panel's decision.

You will receive the panel's decision by letter.

Admission authorities must keep to the decisions of admissions appeals panels. The decisions can only be changed by the courts.

Appeals for infant classes (reception, year 1 and year 2) – the '30 children in a class' rule.

By law, we cannot teach infant children in classes of more than 30. If there were more than 30 children, the local authority would have to take 'special measures'. This means we would have to:

- build another classroom;
- employ another teacher; or
- do both.

When we refuse your child a place because we would have to take special measures, you can only win an appeal if:

- the admission arrangements did not keep to the law and your child would have been offered a place if they did;
- the appeal panel decides that our decision not to offer a place was unreasonable in your circumstances (an unreasonable decision is one that no sensible authority acting properly would make); or

 we made a mistake or did not follow the right procedure when we decided on places at the school and we would have given your child a place if we had done things correctly.

After the hearing

If you are unsuccessful in your admission appeal, you may want to consider the following options.

1 Complaints to the Local Government Ombudsman

The Local Government Ombudsman can investigate written complaints about bad administration by an admission appeal panel. This is not a right to appeal and has to relate to issues such as failing to follow correct procedures or failing to act independently and fairly, and does not relate to the person making the complaint who thinks the decision is wrong.

2 Complaints to the Secretary of State

The Secretary of State cannot review or change decisions of individual appeals panels but can consider:

- whether the local authority set up the appeal panel properly, with the right number and properly appointed types of panel members; and
- whether the admission authority or governing body has acted reasonably when running the appeal meeting and handling the decision-making process.

3 Judicial review

You can ask for a judicial review if you disagree with the decision or you thought it was 'unreasonable'. An 'unreasonable' decision is one that no sensible authority acting properly would make. You will usually have to contact a solicitor about this.

Further appeals

We will normally only let parents appeal once to a particular school in any school year.

We will only consider an application for the same school in the same school year in exceptional situations, such as a significant and material change in your or your child's circumstances (for example, a change of address from a different area which would put your application in a higher priority group). If your child is distressed at not being offered a place at the school they wanted, we do not consider this as a significant and material change in circumstances.

Information about schools

Open days

Wigan schools will hold open days for parents and pupils. You can contact each school for details.

School prospectus

The governors of each school publish a prospectus which contains information about the school such as policies, results and lessons. You can get a free prospectus from each school. You can download some school prospectuses from the school's website. The website address is shown on the page for each school.

Ofsted reports

Schools are regularly inspected by the Office for Standards in Education (Ofsted). You can get copies of Ofsted reports from schools or read them on the Ofsted website at www.ofsted.gov.uk

General information

School meals

School meals are available in all primary schools at the moment.

There is a cafeteria for pupils who want to buy a school meal. There are places at all schools where pupils can eat food they have brought from home.

Children whose parents receive the following support payments are entitled to receive free school meals.

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- Child Tax Credit, as long as they are not entitled to Working Tax Credit and have a yearly income (as assessed by HM Revenue & Customs), as of April 2009, of no more than £16,190
- The guaranteed part of Pension Credit

We do not provide milk for any pupils in Wigan schools.

School uniform

Pupils must wear school uniform at all primary schools in Wigan. You can get details about this from the individual schools.

Bus services

Greater Manchester Passenger Transport Executive (GMPTE) manages school bus services, and they charge children 80p for each journey.

To find details of school routes and other bus services, you can use our website at www.wigan.gov.uk which has links to other sites. You can also get leaflets from Wigan and Leigh bus stations. For more information, phone GMPTE on 0161 228 7811 or use GMPTE's website at www.gmpte.gov.uk.

Help with travel

We will provide a free travel pass for children aged under 11 who have to travel more than two miles to their nearest available school. We will measure this by a reasonable walking route. We will not offer help if your child goes to a school more than two miles away and there is a school nearer with a place available.

How we will measure the distances

We will measure the two-mile limit along the nearest and shortest suitable walking route.

You can get claim forms from the school or the Integrated Transport Unit.

Sustainable school travel

The school run adds around 20% more cars to early-morning traffic. For many parents, children and young people, the journey to school or college is ideally suited for walking, cycling or using buses and trains.

Our 'Sustainable Modes of Travel Strategy' encourages children and young people in the area to change their behaviour and attitudes towards school travel. Section 508A of the Education Act means all local authorities are responsible for promoting the use of sustainable (environmentally friendly) travel and transport for children and young people of sixth-form age and below. This covers not only those children and young people who live in Wigan borough, but also those who live outside the area and travel into Wigan for education and training.

The Local Transport Plan recognises the benefits for the environment, as well as the benefits for children's health and well-being, by encouraging walking and cycling. It also aims to tackle built-up traffic around schools and make it easier for children and young people to get to school.

School travel map

We set up our school travel interactive service to help provide sustainable school travel (go to www.wigan.gov.uk/schooltravel). This service provides information for every school and college in the borough to help them choose different types of transport.

Every school in the borough has already received a map with details of options for travelling to school, so that children and parents can decide how to travel. The map includes locations for the following.

- All schools
- School crossing patrols
- Pedestrian crossings
- Bus stops
- School bus routes
- Cycle routes (you can also find information about where cycle lockers and other cycling facilities are at schools)

We are always developing and improving the information we provide and, in time, we hope to include whether the school has:

- a travel plan;
- a 20mph zone;
- routes away from the main road which are easy to access;
- safer alternatives to busy roads;
- a 'Safer Routes to School' scheme; and
- a 'walking bus' scheme (where children walk to school in a supervised group).

You can help in a lot of ways, by thinking about how your child gets to school, but also by asking your school whether they have developed, and if they are putting into place, their school travel plan. If your school already has a travel plan, you could help to set up a junior road-safety team or a school travel council. This would be made up of children from the school, who can take responsibility for the plan, come up with their own ideas to encourage and promote sustainable travel and work towards achieving the travel plan targets.

You could also get involved in a walking-to-school or cycling-to-school scheme, by supervising groups of children to walk or cycle together.

We want to make sure that a new kind of school travel can develop so that we can make the school journey safer and healthier for everyone.

Transfer between primary schools

If you want to change your child's school, you should consider this decision very carefully. It is normally in your child's best interests to stay at the same school, as changing schools can cause an unnecessary break in the child's education. If your child is having problems, a change of school is not always the answer. You should discuss any concerns with your child's head teacher before you apply for a different school.

If you are thinking of moving house and this means your child would have to change school, there may not be places available at the school you want. The School Places Team will be able to tell you which schools are full or have places available. Some schools are full in all or most year groups and we cannot guarantee there will be a place available in the area you want to move to.

How to apply for a school transfer

Wigan residents

Wigan Council's School Places Team deals with applications to transfer schools.

If you are a Wigan resident and you want to apply for a school transfer, please complete the Wigan Council in-year application form. This form is available on the Wigan Council website at www.wigan.gov.uk or from the School Places Team by phoning 01942 486040.

You can name up to three schools in order of priority, either in Wigan or another local authority. If you name a school in another local authority area we will deal with the other authority for you. We will write to let you know that we have received your application against their faith criteria.

If any of your preferred schools is a voluntary-aided (church) school, you will need to fill in the school's own supplementary information form and return it with your Wigan Council in-year application form. You can get a copy of the supplementary form from our website at www.wigan.gov.uk, from the School Places Team or from the school. If you do not fill in the school's own supplementary information form, the school will not have all the information they need to consider your application against their faith criteria.

We will write to let you know the result of your application. All schools have an admission number for each year group. If we cannot offer you a place at the school you want and you live in Wigan, we will offer you a place at another school. You may want to keep your child at their current school. You have the right to appeal if we refuse you a place at a school. For more information on appeals, see page 22 We do not keep waiting lists for transfers during a school year. If you have appealed for a place at a school and a place becomes available before your appeal is heard your application will be considered alongside any other applications for that school. It is important that your child continues to attend their current school until a transfer date has been arranged.

Residents of other local authorities

If you do not live in Wigan you can still apply for a place in a Wigan primary school, but you must apply on your home local authority in-year application form. The home local authority will send details to the School Places Team in Wigan. Voluntary-aided school supplementary information forms for Wigan schools should be sent to the individual school.

We will let your home local authority know when we receive your application and let them know the result. Your home local authority will then write to you. You can appeal if you are refused a place at a school. For more information on appeals, see page 22

Applications for children moving into Wigan

If you want to apply for a Wigan school because you are moving to Wigan soon, you can use the Wigan Council in-year application form and return it to the School Places Team in Wigan. You must send proof of the address you will be moving to and the date you will be moving with your application.

Offers of school places

You need to accept the offered place within two weeks of the offer date.

Once we have allocated your child a place at a school, they must start school within four school weeks. If they don't the place will be withdrawn. If you still want your child to transfer you will need to reapply. Please remember this if you are moving house.

Fair access protocol

We sometimes get requests for places from Wigan residents but are not able to offer a place at a school within a reasonable distance of where the child lives. In these situations, the Director of Children and Young People's Services will use our 'fair access protocol' to allocate a place at a community, voluntary-controlled, foundation or voluntary-aided (church) school, even if the year group is full.

Children who qualify for a place using our fair access protocol must be given priority over children on a waiting list who attend a school.

Plain English Campaign's Crystal Mark does not apply to the rest of this booklet.

- 2. Children whose older brothers or sisters attend the school and who will still be there at the time of admission.
- 3. Children from Leigh CE Infants' School and Leigh St John's Infants' School with equal priority.
- Children living closest to the school.

Over-subscription Criteria for Hindley Junior and Infant School

Hindley Junior and Infant is a fully inclusive school with facilities to accommodate children with a wide range of complex needs.

Where the school receives more applications than places available, the following oversubscription criteria will be applied once places have first been allocated to pupils who have a statement of special educational need which names the school:

- 1. Children in public care.
- 2. Children with physical and / or medical difficulties who the Local Authority have determined, following an assessment of the child's needs, require a resourced place at the school.
- 3. Children whose older brothers or sisters attend the school and will still be there at the time of admission
- 4. Children who live closest to the school.
