This is a regional workshop focused on fostering effective partnership working and joint commissioning across education, health and care.

The invitation is to leaders from local areas representing education, health and care services to attend one of a series of regional workshops on developing and sustaining effective practice in partnership working and joint commissioning within local SEND systems. These workshops will build on the series of Local Government Association workshops, facilitated by Isos, that ran in the summer of 2018, which informed the publication, *Developing and* 

sustaining an effective local SEND system. LGA anticipate that these workshops will be of interest to and attended by colleagues with responsibility for education and inclusion, children's services, adult services and a range of local health services for children with additional needs, as well as elected members of local councils.

#### What will the workshops cover?

In the previous round of regional SEND good practice workshops that ran in 2018, Isos colleagues collected a wide range of perspectives about what makes for an effective local SEND system, as well as many examples of good practice. These formed the basis of the publication, *Developing and sustaining an effective local SEND system*. One of the six key themes in that document was partnership working and joint commissioning across education, health and care. The outcomes of several recent local area SEND inspections suggest this continues to be an area in which local SEND systems are seeking to strengthen. This is a particular focus of the new SEND System Leadership Board, chaired by Christine Lenehan, of which the Local Government Association is a member. Each workshop will provide opportunities for colleagues to:

 $\hfill \Box$  reflect on the strengths and areas for development around partnership working and joint commissioning within their own local area;

□ hear about examples of effective practice and new ideas from other local areas;
 □ help to define a set of key practical messages for developing and sustaining effective partnership working and joint commissioning; and

□ contribute to shaping key findings about what is needed at local, regional and national level to strengthen partnership working and joint commissioning.

#### Who should attend?

The workshops are for colleagues from across education, health and care in local SEND systems. This includes strategic leaders and heads of service for SEND and inclusion, children's social care, adult services and local health services, as well as elected members for local councils. The sessions have been designed to allow partners from a local area to reflect on the strength of their partnership working together. # **CONSULTATIONS**

### **SEND Information, Advice and Support Services.**

National Children's Bureau (NCB) has been commissioned by the Department for Education to conduct a customer satisfaction survey collecting feedback from all those who have sought the help of SEND Information, Advice and Support (IAS) Services. This includes children and young people, their parents, carers, friends and family and professionals. SEND IAS Services provide information, advice and support to disabled children and young people (and those with Special Educational Needs), and their parents/carers. All local authorities are required to make sure these services are available on a free, impartial and confidential basis.

NCB is encouraging anyone who has used, or tried to use, these services in the last 12 months to take part in a short survey which should take around seven minutes to complete. The survey can be accessed here.

### DfE consultation on school transport

The Department for Education is carrying out a consultation about <u>updating the statutory</u> guidance for local authorities on home to school travel and transport.

The consultation runs from now until 31 October. You are encouraged to share more widely with people with an interest in the implications for pupils with SEN, disabilities or medical conditions to submit responses.

School transport generally is clearly of major importance to pupils with SEND. In addition, specific issues touched on in the guidance and the consultation document include:

- Travel training
- Behaviour during travel
- Support for pupils with medical conditions

DfE have asked for your help to ensure that the decisions that will be taken by Ministers following the consultation are informed by consideration of the full implications for pupils with special educational needs, disabilities and medical conditions.

#### Restraint guidance and consultation

On 27 June, the Department for Education (DfE) jointly published non-statutory **guidance** with the Department for Health and Social Care (DHSC) on reducing restraint and restrictive intervention in health and social care services and special education settings. The guidance aims to help settings adopt a preventative approach to supporting children and young people

whose behaviour challenges as a result of learning disabilities, autistic spectrum conditions or mental health difficulties.

It sets out relevant law and guidance and provides a framework of core values and key principles to support a proactive approach to supporting children and young people who have behaviour challenges; and a reduction in the need to use restraint and restrictive

At the same time, the DfE published a consultation to gather views on whether there is a need for guidance on reducing restraint and restrictive interventions for mainstream schools. mainstream post-16 settings and Alternative Provision; and whether guidance should apply to a wider cohort of children and young people with special educational needs and disabilities.

# SHARING PRACTICE ACROSS THE NORTH WEST

### The Wigan Deal

Over a period of six years, public services in Wigan have been through a major process of transformation, based on the idea of building a different relationship with local people. The new approach to delivering services has become known as the Wigan Deal.

A report from the King's Fund provides an independent critique of the Wigan Deal drawing on in-depth research, including interviews with key stakeholders, focus groups with members of the public and evidence from data analysis. It explores what local authorities, NHS organisations and others can learn from Wigan's journey of transformation.

It tasks local areas to demonstrate how proposals for children and young people with learning disabilities, autism or both align with their plans for mental health, SEND, children and young people's services and health and justice. # REPORT:

#### It takes leaders to break down siloes

This Council for Disabled Children report on integrating services for disabled children was supported by the True Colours Trust. The report draws upon considerable expertise and consultation with professionals and parent carers to identify key factors that are helping and hindering the integration of services around special educational needs and disability (SEND). Key findings from the report include:

- The system of disabled children's services, nationally and locally, is highly complex and fragmented. Those who work in it face multiple practical barriers to integration.
- Leadership is the most important factor in enabling or hindering integration; service leaders play a pivotal role in uniting agencies around a whole-system approach to SEND and wider vulnerable children's services.
- Good quality population data is vital to developing a whole-system approach, and the measurement of shared outcomes.
- Local areas' efforts to integrate services in the complex SEND system must be part of a wider strategic vision

# SEND Casework Award – training and accreditation for local authority SEND staff

The SEND Casework Award by nasen (National Association for Special Educational Needs) is the only on-the-job training accreditation written specifically for those directly involved in local authority SEND casework. It launched in 2018, and since then, has helped to train nearly 100 candidates nationally. Course content includes:

Technical and legal aspects of SEND assessment;

- Review and coordination process, with particular reference to the Code of Practice (2015):
- Interpersonal, communication and self-management skills required by staff for effective and excellent professional practice.

The award is particularly beneficial for those coordinating or supporting co-production and professionals working with children, young people, parents and/or carers through the education, health and care needs assessment process. Several local authorities are also using the award as part of their induction programme for new staff, reflecting the importance of the Award when training and developing team members.

# **Young Epilepsy Guide**

Young Epilepsy, the national charity for children and young people living with epilepsy, is proud to launch its new online guide for schools: **Guide for Schools.** 

Epilepsy is one of the most common long-term conditions in childhood and it can have a significant impact on learning and behaviour, even if seizures are controlled. The charity's recent work showed that many school staff did not know some of the basics to keep a child safe during a seizure. At the same time, misunderstanding was also leading to exclusions from normal school activities such as physical education. This exclusion can add to feelings of isolation and anxiety for young people with the condition.

The guide provides information on supporting young people with epilepsy to ensure they are safe and included at school. This includes seizure first aid and suggested support strategies in learning and behaviour. State schools in England have a specific legal duty to support pupils with medical conditions and this support forms a crucial part of the school's safeguarding and equality duties.
