QS/284/4 – Appointment of Quarter Sessions Court to sit on Wednesday 23rd July, Joseph Catterall – 23rd July 1873

QS/284/5 – Jurors decision – James Connor stole ten ounces from Alfred Walker whilst being his servant. Previous Conviction of felony. Pleaded not guilty and found not guilty. – 13th May 1873 and 1st July 1869.

QS/284/6 – List of previous convictions for James Connor, alias James Worthington from the 21^{st} July 1869 – kept for nine calendar months hard labour. – 18^{th} July 1873.

QS/284/7 –True Bill - Indictment of previous convictions for William Johnson and Elizabeth Warren (Mary Ann Bretherton and William Mellor alias') – 1873.

QS/284/8 – Remembrance of the robbery of Thomas Dorsington, by William Mellor – three calendar months hard labour – 23rd July 1873. (1863 crime occurred)

QS/284/9 – Remembrance of Mary Ann Breserton – theft of one shirt from Edward Foley - three calendar months – 31st Jan 1873.

QS/284/10 – John Billsborough stole 21 pounds weight of brass – two calendar months sentence – Pleaded guilty. – 13^{th} May 1873

QS/284/11 + QS/284/12 – Remembrance of William Kendrick – Stole 46 pounds weight of Iron property of John Hunter. Previous Conviction – he stole a sixty pound iron weight and previous conviction of felony. – 18th July 1873.

QS/284/13 + QS/284/14 – Indictment of Margaret Delaney, stole a purse and 7 shillings, half a penny – sentenced to 9 calender months. True Bill – conviction plea of guilty in Leeds – Mary Brown alias – stole from the Oliver family in Leeds (14^{th} and 15^{th} July 1871) - 14^{th} June 1873

QS/284/15 + QS/284/16 – Andrew Keeghan stole two coats one vest and one pair of trousers. Pleaded guilty, previous conviction – Felony as Andrew Heighan – alias. True Bill – stole 8 shillings, 3 pence in money and one bag. – 26th October 1868 +19th June 1873.

QS/284/17 – Indictment of William Deary – stole a chain and one locket, valued 24 pounds and 10 shillings – sentenced to 15 months hard labour – True Bill – 21st June 1873.

QS/284/19 – Remembrance of recognisance of William Kendrick who stole 60 pounds weight of Iron of the property of John Hunter summoned to give evidence and consequences should he fail to. 9th June 1873.

QS/284/21 – Remembrance and recognisance of detective sergeant Samuel Marshall and John Hopkins. Andrew Keeghan stole coats, one vest, and two pairs of trousers. Marshall and Hopkins need to give evidence against Keeghan. – 26th June 1873.

QS/284/22 – Recognisance and Remembrance of Thomas Englishly and William Deary. Englishly fined if he does not give a witness statement against Deary. – 1873.

QS/284/23 – Recognisance of William Johnson and Elizabeth Warren crimes. Recognised that witnesses must appear of fined 25 pounds each. Patrick O'Brien and Harriet Bircks.

QS/284/24 – Remembrance and recognisance of Patrick McMahon and William Taylor's statement against James Connor – 1873.

QS/284/25 – Remembrance of John Rimmer, stole one shirt from William Ollenshaw and found guilty – ten days hard labour – 5^{th} May 1873.

QS/284/26 – Remembrance of Conviction of James Thompson – stole 6 yards of cotton print. Received 7 days hard labour. 19th May 1873.

QS/284/27 – Remembrance – Richard Makinson – stole one chain from James Holmes – 14 days hard labour – 19th May 1873.

QS/284/28 – Remembrance of Ann Stones stealing one shawl, one jacket property of Charles McEwen imprisoned for 14 days. – 29th May 1873.

QS/284/29 – Remembrance of Catherine McMurray, who stole 1 coat, the property of Joseph John Dellis – 2^{nd} June 1873.

QS/284/30 – Remembrance of Henry Leevin who stole two flutes property of William Thompson – 21 days hard labour – 9th June 1873.

QS/284/31 – Remembrance of John Smith who stole one coat – received one month's imprisonment – 16th June 1873.

QS/284/34 – Remembrance of John Doyle who stole one pair of scissors property of William Lutherland – 14 days hard labour – 8^{th} May 1873.

QS/284/35- Remembrance of Henry Houghton who stole a duck from Richard Grundy received 14 days hard labour. - 10th July 1873.

QS/284/36 – Remembrance of John Fallan who stole one whip from William King and received 14 days hard labour. -10^{th} July 1873.

QS/284/37 – Ann Watson stole one shirt from Richard Roper, received 3 days hard labour. 17th July 1873.

QS/284/38 – Remembrance of Mary Clarke stole one shirt and one pair of boots from Patrick Barragon received 14 days hard labour – 21st July 1873.

QS/284/39 – Remembrance of Ann Watson who stole one sheet from Mary Rowan, sentenced to 14 days hard labour – 21^{st} July 1873.

QS/284/40 – Remembrance of William Taylor *Juvenile Offence* (Under the age of 16) stole a riddle property of Ann Jones . Received ten strikes with a birch tool. -17^{th} July 1873

QS/284/41 – Remembrance of Joseph Gregson *Juvenile Offence* who stole 4 shillings and 1 penny from Alfred Walker. Received 6 strokes with birch wood. -3^{rd} July 1873.

QS/284/42 – Remembrance of William Burtonwood guilty of riotous conduct in a public place. Sentenced to one calendar month hard labour -3^{rd} July 1873.

QS/284/43 – Remembrance of Richard Barrow guilty of assaulting John Dray. Pay 5 shillings to the court and 10 shillings and 4 pence to John Dray. If not 14 days hard labour would be enforced. -23^{rd} June 1873.

QS/284/44 – Remembrance of Robert Disley who assaulted and beat Elizabeth Atkinson. To pay 10 shillings to the court and and 11 shilling 6 pence to Atkinson, otherwise 14 days hard labour. -23^{rd} June 1873.

QS/284/45 – Remembrance of Charles Horburn who assaulted and beat Orwald Joseph Polling. To pay 4 shillings and 6 pence to the court and 10 shillings 6 pence to Polling, otherwise 2 months hard labour – 22^{nd} May 1873.

QS/ 284/46 – Remembrance of Elizabeth Hall who left her job without permission, owes 2 shillings and 6 pence to court. Has to pay 9 shillings and 6 pence to Thomas Taylor Brother or serve 14 days hard labour – 13^{th} June.

QS/284/47 – Remembrance of James Cowell who tried to free Arthur Wilson from the police station whilst under police custody of Robert Bedford. Has to pay 10 shillings to the court and 9 shillings and 10 pence to Bedford to avoid 14 days hard labour – 21^{st} July 1873.

QS/284/48 – Thomas Hogg drunk during prohibited hours has to pay 5 shillings to the court and pay Wrigley Dobson 7 shillings and 10 pence to avoid 14 days hard labour – 21^{st} July 1873.

QS/284/49 – Remembrance of Margaret Morton who beat Alfred Higham. Has to pay 2 shillings and 6 pence to the court and pay 9 shillings and 7 shillings 6 pence to Higham to avoid 14 days hard labour. -21^{st} July 1873

QS/284/50 – Remembrance of Terence Carling who left his job without any lawful notice or cause. To pay 2 shillings and 6 pence to court and 9 shillings and 6 pence to Thomas Taylor Brother to avoid 14 days hard labour. – 22^{nd} May 1873

QS/284/51 – Remembrance of John Fairhurst who assaulted David Barren. Has to pay 10 shillings to the court and 13 shillings to Barren to avoid 14 days hard labour. -3^{rd} July 1873.

QS/284/52 – Remembrance of William Waddington who willingly broke the property of Martin Conway and has to pay 5 shillings and 6 pence for the damage and 8 shillings and 10 pence for the costs on Conways behalf to avoid 14 days hard labour – 20^{th} May 1873.

QS/284/53 – Remembrance of David Hill assaulted Joshua Sillifant (he being a constable) to pay 20 shillings for offence and 8 shillings 6 pence to Joshua, or face 1 month hard labour. – 5^{th} May 1873.

QS/284/54 – Remembrance of William Culshaw who did obstruct Norman Barton who was an officer of Lancashire and Yorkshire railway company which then and there did execute his duty in the company. Culshaw is to pay 10 shillings to court and 10 shillings and 10 pence to Barton. - 29th May 1873.

QS/284/55 – Remembrance of William Dawber who assaulted Michael Siney, to pay 5 shillings according to law and 11 shillings 6 pence to Siney, to avoid 14 days hard labour. 29th May 1873.

QS/284/56 – Remembrance of Thomas Conlin who assaulted Thomas Pepper who was a constable and then and there his duty was executed. To pay 10 shillings to court and 8 shillings and 10 pence to Pepper. – 12^{th} May 1873.

QS/284/57 – Remembrance of John Edwards who was a constable but who unlawfully beat William Forran, to pay 10 shillings according to law and 12 shillings 6 pence to Forran to avoid 14 days hard labour. – 12th May 1873.

QS/284/58 – Remembrance of Thomas Mc Nulty who damaged the property of Charles Oldfield to the amount of 2 shillings and 6 pence (copper lid) and had to pay 10 shillings according to the law and pay Oldfield 9 shillings 10 pence to avoid 1 month hard labour. -23^{rd} May 1873.

QS/284/59 – Remembrance of Henry Mason who broke a cradle belonging to Isaac Tinsley which amounted to 4 shillings and 6 pence. Has to pay 5 shillings and 4 shillings and 10 pence for the damage according to the law and pay Tinsley 18 shillings and 10 pence to avoid 14 days hard labour. – 1^{st} July 1873.

QS/284/60 – Remembrance of James Mc Cafue who obstructed a public thoroughfare. To pay 2 shillings and 6 pence according to law and pay James Dobson 8 shillings and 6 pence or face 7 days hard labour. – 4th July 1873.

QS/284/61 – Remembrance of John Graham who assaulted Charles Taylor. To pay 10 shillings according to the law and 1 pound, 1 shilling and 6 pence to Taylor to avoid 14 days hard labour – 3^{rd} July 1873.

QS/284/62 – Remembrance of Anthony Barrister who wilfully obstructed a highway. To pay 5 shillings according to law and to pay Patrick O'Brian 7 shillings and 10 pence to avoid 14 days hard labour. -23^{rd} June 1873.

QS/284/63 – Remembrance of Joseph Oakes who assaulted Elizabeth Blackledge. To pay 40 shillings according to the law and to pay Elizabeth 15 shillings and 6 pence to avoid 2 calender months hard labour – 9^{th} June 1873.

QS/284/64 – Remembrance of Thomas Crook who assaulted Joseph Clough. To pay 10 shillings to law and 11 shillings and 6 pence to Crook to avoid 14 days in prison. – 7^{th} July 1873.

QS/284/65 –Remembrance of William Halliwell who damaged property of Herbert Spencer Woodcock by walking on has grass to the amount of 1 penny. To pay 2 shillings and 6 pence and one penny according to law and pay Spencer 9 shillings and 6 pence for the damage – 22^{nd} May 1873.

QS/284/66 – Remembrance of Patrick Mcloughlan who assaulted Mary Lennon. To pay 10 shillings for offence and pay Mary 18 shillings and 6 pence to avoid 14 days hard labour – 10^{th} July 1873.

QS/284/67 – Remembrance of Joseph Fairhurst who beat Thomas Love (who was a police constable) and who's post was executed thereafter. To pay 10 shillings according to law and pay Love 9 shillings and 10 pence. – 3^{rd} July 1873.

QS/284/68 – Remembrance of Alexander Woodward who left his job unlawfully. Owes 5 shillings according to law and owes William Johnson and Co. 8 shillings and 6 pence for costs on his behalf. -10^{th} July 1873.

QS/284/69 – Remembrance of John Manning who left his job unlawfully from James Ickersley and sons limited. Owes 5 shillings according to law and the company 8 shillings and 6 pence to avoid 14 days hard labour. -10^{th} July 1873

QS/284/70 – Remembrance of Benjamin Callard who left his job at James Ickersley and Sons LTD unlawfully. To pay 5 shillings according to law and pay company 8 shillings and 6 pence to avoid 14 days hard labour – 10th July 1873

QS/284/71 – Remembrance of John O'Brien who assaulted Margaret Donnaghue. Owes 5 shillings according to law and owes Margaret 18 shillings for the costs – or face 14 days hard labour – 10^{th} July 1873.

QS/284/72 – Remembrance of John Atherton who assaulted David Barren. Atherton owes 10 shillings according to law and owes 13 shillings to avoid 14 days hard labour. – 3^{rd} July 1873

QS/284/73 – Remembrance of James Kelley who assaulted Thomas Clitheroe (then and there being a constable) as a result his employment was executed. To pay 50 shillings according to law and 1 pound, 2 shillings, and 4 pence to Clitheroe to avoid two calendar months – 14th July 1873

QS/284/74 – Remembrance of Thomas Jones who assaulted Thomas Clitheroe (then and there a constable) and his employment was terminated as a result. To pay 50 shillings according to law and 1 pound, 2 shillings, and 4 pence to Clitheroe to avoid two calendar months – 14th July 1873

QS/284/75 – Remembrance of John Eastcote who assaulted Terrence Clune. To pay 10 shillings according to law and 13 shillings to Clune to avoid 14 days hard labour – 14^{th} July 1873.

QS/284/76 – Remembrance of Annie Cunningham who was arrested as a prostitute and working in a public street behaving in a riotous manner, sent for 21 days hard labour – 13^{th} May 1873.

QS/284/77 – Remembrance of Maria Lee who was arrested as being a prostitute and working in a public street, given 14 days hard labour – 13th May 1873.

QS/284/78 – Remembrance of Mary Shannon who was arrested for being a prostitute and working in a public street, given 14 days hard labour – 13^{th} May 1873.

QS/284/79 – Remembrance of Mary Hall who was arrested for being a prostitute, sent for 14 days hard labour – 13^{th} May 1873.

QS/284/80 – Remembrance of Mary O'Neill who was arrested for being a prostitute, rogue and vagabond, sentenced to 21 days hard labour – 3^{rd} July 1873.

QS/284/81 – Remembrance of Gerrard Ince who was found in John Harrison's yard trespassing, sentenced to 14 days hard labour – 14th July 1873.

QS/284/82 – Rememberance of Patrick Mahon who was guilty of riotous behaviour whilst drunk. To pay 5 shillings according to law and Thomas Ruller 7 shillings and 10 pence to avoid 14 days hard labour. -12^{th} May 1873

QS/284/83 – Rememberance of Thomas Carlin for being drunk and must pay 5 shillings according to law and pay Thomas Pepper 7 shillings and 6 pence to avoid 14 days hard labour.- 12th May 1873.

QS/284/84 – Rememberance of Michael Thurstan who was guilty of being drunk and who must pay 5 shillings according to law and 8 shillings and 10 pence to William StJohn to avoid 14 days hard labour – 5^{th} May 1873.
