This declaration applies also to materials supplied from the collections and photographed using personal cameras.

We will be unable to supply you with the copies you require until payment and a completed form has been received (notes of charges appear on the order form).

- Charges are calculated to include costs for staff time to locate and copy material.
- It may not be possible to provide an accurate quote for the price of a postal order in advance. Once work is complete staff will notify you of the total cost of your order (copies, postage and staff time) and once payment is received your copies will be sent.

- This form should also be completed for users of personal cameras in the searchroom even if no charges are applicable, recording items photographed below.
