Reproduction Order Form and Copyright Declaration

If you are requesting copies of material from the Archives and Local Studies collections, or microform/computer print-outs, you will be asked to complete this order form and copyright declaration. This declaration applies also to materials supplied from the collections and photographed using personal cameras.

We will be unable to supply you with the copies you require until payment and a completed form has been received (notes of charges appear on the order form).

Declaration

1. Please supply me with copies – digital or paper – of the items listed overleaf.
2. I declare that:
 - a. I have not previously been supplied with a copy of the same material by you or any other archivist or librarian
 - b. I will not use the copy except for non-commercial research or private study and will not supply a copy of it to any other person
 - c. FOR UNPUBLISHED MATERIAL ONLY: To the best of my knowledge the work has not been published before the document was deposited with Wigan Archives & Local Studies and the copyright owner has not prohibited copying of the work
 - d. FOR PUBLISHED MATERIAL ONLY: To the best of my knowledge no other person with whom I work or study has made or intends to make, at or about the same time as this request, a request for substantially the same material for substantially the same purpose
3. I declare that the copy will not be altered, transmitted electronically or displayed in any format (including online) and that it will not be further copied
4. I understand that if this declaration is false in a material particular the copy supplied to me by you will be an infringing copy and that I shall be liable for infringement of copyright as if I had made the copy myself.
