EXPLANATORY NOTES FOR APPLICANTS

- 1. <u>DELETION</u> of a public right of way. Read form W.C.A. 1 and complete forms W.C.A. 5, 6, and 7 as appropriate.
- 2. <u>CLAIMED</u> new public right of way. Read form W.C.A. 2 and complete forms W.C.A. 5, 6, and 7 as appropriate.
- 3. <u>UP/DOWNGRADING</u> of a public right of way. Read form W.C.A. 3 and complete forms W.C.A. 5, 6, and 7 as appropriate.
- 4. <u>VARIATION TO THE STATEMENT</u> for a public right of way. Read form W.C.A. 4 and complete forms W.C.A. 5, 6, and 7 as appropriate.

It is recommended that maps to accompany applications for Definitive Map Modification Orders are based on Ordnance Survey Maps (at a scale of not less than 1:25000), copies of which are available from all normal retail outlets and Ordnance Survey agents. The Council may be able to supply copies of maps for use with applications for Definitive Map Modification Orders; however you may be able to print areas using the Map page on the Councils website:

IMPORTANT - SERVICE OF NOTICES

Notices of Applications must be served on a named landowner/occupier by one of the following methods; failure to do so will invalidate the application:-

- 1. By personal delivery to the person on whom it is to be served or to whom it is to be given; or
- 2. By leaving it at the usual or last known place of abode of that person or, in the case where an address for service has been given by that person, at that address; or
- 3. By sending it in a pre paid registered letter, or by recorded delivery service, addressed to that person at his usual or last known place of abode, or, in a case where an address for service has been given by that person, at that address; or
- 4. In the case of an incorporated company or body, by delivering it to the secretary or clerk of the company or body at their registered or principal office.

In the event of the name of the landowner/occupier not being known, after making all reasonable efforts to find this information, you should write to the Council giving full details of the steps you have taken. The Council can then direct you to address the Notice in some conspicuous place(s) or to some conspicuous object(s) on the land.

It is a requirement of paragraph 2 of Schedule 14 to the Wildlife and Countryside Act 1981 that all landowners/occupiers be served with Notices as detailed above. You are required to certify to that effect by completing and returning form W.C.A. 7.

The Public Rights of Way Officer will be happy to give guidance in the making of the application should it be required.

GUIDANCE NOTES ON THE COMPLETION OF PUBLIC RIGHTS OF WAY EVIDENCE OF USE FORMS (Form W.C.A. 8)

WILDLIFE AND COUNTRYSIDE ACT 1981

- 1. The witness should complete the form as fully as possible.
- 2. Each witness should complete a separate form in respect of each way about which he/she can give evidence.
- 3. If you provide a plan the witness should draw on the route of the way and initial each end of the route he/she has drawn.
- 4. The route of the way should be described as accurately as possible, giving details of such things as property and field boundaries, stiles, gates, bridges and stepping stones etc.
- 5. Witnesses should indicate whether they are willing to give evidence at a hearing or at a public inquiry. (The evidential value of a statement can be considerably reduced if its contents cannot be tested by cross-examination.)
- 6. If a witness is unable to give evidence at a hearing because of illness or infirmity for-instance, the person obtaining the statement should endorse it accordingly and be ready to give evidence of the circumstances. Additionally a witness can be asked to agree to make a statutory declaration in which case he/she should make a mark on the statement, usually his/her initials, then complete form W.C.A. 9 and make the appropriate declaration before a commissioner for oaths or a solicitor, for which a fee is payable.
- 7. The evidence given on the form may become available for public inspection.

How to apply for a Modification Order to <u>DELETE</u> a public right of way.

1. If possible, please quote the Right of Way number from the Definitive Map, and provide a detailed description of the route and an OS reference. If you require assistance in identifying the path please contact the Councils Public Rights of Way Officer, to arrange an appointment to examine the Definitive Map and Statement.

COMPLETE SECTION 1 ON FORM W.C.A. 5

Documentary evidence required:-

- i) map, not less than 1:25000 (2½" to I mile). A larger scale map would, however, greatly assist the consideration of this claim.
- ii) any evidence considered relevant including:
- a) completed user evidence forms/witness statements
- b) photographs
- c) old maps

RETURN THE COMPLETED FORM W.C.A. 5 AND RELEVANT EVIDENCE TO THE COUNCIL AT THE ADDRESS SHOWN BELOW (see also Note 3 below).

- Notify the landowner or occupier concerned (complete paragraph 1 on Form W. C. A.
 6). This Form must be served on each landowner/occupier affected by your application. (It is essential that the procedures described in the "Note for Service of Notices" in the Explanatory Notes is followed, otherwise the application will be invalidated).
- 2.1 If you cannot find the landowner/occupier, after making all reasonable efforts, you should write to the COUNCIL giving full details of the steps you have taken. The COUNCIL can direct you to address the Notice to the "owner" or "occupier" of the land (describing it) and then to affix the Notice in some conspicuous place(s) or to some conspicuous object(s) on the land.
- 3. COMPLETE FORM W.C.A. 7, LISTING THE LANDOWNER(S) NOTIFIED AND RETURN IT TO THE COUNCIL. If a direction under 2. 1. above has been given, the list on Form W.C.A. 7 should be completed by giving details of the Notices actually served and displayed on the land.

How to apply for a Modification Order to <u>CLAIM</u> a new public right of way.

- 1. Decide whether your claim is for a footpath, bridleway or a byway open to all traffic:
 - a) A footpath is for use by pedestrians only; it may have gates/stiles on it.
 - b) A bridleway is for use by pedestrians, equestrians and cyclists. It should not have stiles unless there are also gates that open.
 - c) A byway open to all traffic is for use mainly by equestrians, cyclists and pedestrians but may be used by vehicles including motorcycles. (Please note that the Council is not obliged to provide a tarmac or bitmac surface).

COMPLETE SECTION 2 ON FORM W.C.A. 5

Documentary evidence required:-

- i) map, not less than 1:25000 (21/2" to I mile). A larger scale map would, however, greatly assist the consideration of this claim.
- ii) any evidence considered relevant which may include:
- a) completed user evidence forms/witness statements
- b) photographs
- c) old maps

The Council can direct you to address the Notice to the "owner" or "occupier" of the land (describing it) and then to affix the notice in some conspicuous place(s) or to some conspicuous object(s) on the land.

How to apply for a Modification Order to <u>UPGRADE/DOWNGRADE</u> a public right of way.

- 1. Decide whether your application is for a footpath, bridleway, or byway open to all traffic;
 - a) A footpath is for use by pedestrians only; it may have stiles/gates on it.
 - b) A bridleway is for use by pedestrians, equestrians and cyclists. It should not have stiles, unless there are also opening gates.
 - c) A byway open to all traffic is for use mainly by equestrians and pedestrians but may be used by vehicles including motorcycles. (please note that the Council do not have to provide a tarmac or bitmac surface).

<u>COMPLETE SECTION 3 ON FORM W.C.A. 5</u> Documentary evidence required:-

- i) map, not less than 1:25 000 (21/2" to I mile). A larger scale map would, however, greatly assist the consideration of this claim.

If you are unsure about the number and location please contact the Councils Public Rights of Way Officer, to arrange an appointment to view the Definitive Map and Statement or you can view the Map page on the Councils website: http://www.wigan.gov.uk/Maps/Public-Rights-of-Way-Map.aspx
