HIGHWAYS ACT 1980 AND ACQUISITION OF LAND ACT 1981

Wigan Borough Council (in this order called "the Acquiring Authority") hereby make the following Order:-

- 1. Subject to the provisions of this Order, the Acquiring Authority are, under Sections 239, 240 and 260 of the Highways Act 1980 hereby authorised to purchase compulsorily for the purpose of:
 - a) the construction and improvement of highway between J26 M6 Orrell and A49 Warrington Road, Wigan;
 - the construction of other highways, the improvement of existing highways and the provision of private means of access in pursuance of The Wigan Borough Council (M58 Orrell – Pemberton Link road, Wigan) (Classified Road) (Side Roads) Order 2018; and
 - c) use by the Acquiring Authority in connection with the construction and improvement of highways and the provision of new access to premises aforesaid of the land which is described in the schedule hereto and is delineated and shown coloured pink on the map hereinafter mentioned. The map is a map consisting of 7 sheets numbered Plan 1 to Plan 3 with separate inset plans numbered Plan 1a,
- 2. The map is a map prepared in duplicate, sealed with the Common Seal of the Acquiring Authority and marked "map referred to in The Wigan Borough Council (M58 Orrell Pemberton Link Road, Wigan) Compulsory Purchase Order 2018". One duplicate of the map is deposited in the offices of the Secretary of State for Transport.
- 3. Parts 2 and 3 of Schedule 2 to the Acquisition of Land Act 1981 are hereby incorporated with this order.
