**BACK MESNES STREET, WIGAN – PROHIBITION OF WAITING AND RESTRICTION OF  
LOADING**

**NOTICE OF PROPOSALS**

**NOTICE IS HEREBY GIVEN** that Wigan Borough Council, in exercise of the powers under Section 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984, proposes to make the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 192) Order 2025.

The effect of the Order will be to introduce no waiting at any time on:

<b>Road</b>	<b>Side</b>	<b>From</b>	<b>To</b>
Back Mesnes Street, Wigan	West	Its junction with Northway	A point 50 metres south of its junction with Northway
Back Mesnes Street, Wigan	East	Its junction with Northway	A point 25 metres south of its junction with Northway

There will be limited exceptions permitting vehicles to wait to enable people to board or alight; for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers; for local authority, Water Companies and Post Office purposes; if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles) or in connection with a funeral; to take on fuel, water or air at any garage; for the delivery or collection of goods and for loading or unloading; or the avoidance of an accident.

The effect of the Order will be to introduce restricted loading on:

<b>Road</b>	<b>Side</b>	<b>From</b>	<b>To</b>	<b>Period of Operation</b>
Back Mesnes Street, Wigan	West	Its junction with Northway	A point 50 metres south of its junction with Northway	Monday, Tuesday, Wednesday, Thursday, Friday and Saturday  8am – 6pm
Back Mesnes Street, Wigan	East	Its junction with Northway	A point 25 metres south of its junction with Northway	Monday, Tuesday, Wednesday, Thursday, Friday and Saturday  8am – 6pm

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.
