**KIRKHAL LANE, LEIGH – PROHIBITION OF WAITING**

**NOTICE OF PROPOSALS**

**NOTICE IS HEREBY GIVEN** that Wigan Borough Council, in exercise of the powers under Section 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984, proposes to make the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.155) Order 2025.

The effect of the Order will be to revoke no waiting at any time on:

- Kirkhall Lane, Leigh (south side) from its junction with Atherleigh Way to its junction with the road adjacent to No.47 Kirkhall Lane
- Kirkhall Lane, Leigh (south side) from a point 45 metres east of its junction with Gordon Street to its junction with Leigh Road
- Kirkhall Lane, Leigh (north side) from its junction with Cavendish Street to its junction with Leigh Road
- Kirkhall Lane, Leigh (south side) from a point 10 metres west of its junction with Glebe Street to a point 10 metres east of its junction with Glebe Street
- Kirkhall Lane, Leigh (south side) from a point 10 metres west of its junction with Gordon Street to a point 10 metres east of its junction with Gordon Street
- Kirkhall Lane, Leigh (north side) from a point 18 metres west of its junction with Byrom Street to a point 10 metres east of its junction with Byrom Street
- Kirkhall Lane, Leigh (north side) from a point 10 metres west of its junction with Newall Grove to a point 10 metres east of its junction with Newall Grove
- Kirkhall Lane, Leigh (north side) from a point 10 metres west of its junction with Cavendish Street to its junction with Cavendish Street

The effect of the Order will be to introduce no waiting at any time on:

- Kirkhall Lane, Leigh (north side) from a point 18 metres west of its junction with Byrom Street to a point 10 metres east of its junction with Newall Grove
- Kirkhall Lane, Leigh (north side) from a point 10 metres west of its junction with Cavendish Street to its junction with Leigh Road
- Kirkhall Lane, Leigh (south side) from its junction with Atherleigh Way to its junction with Leigh Road

There will be limited exceptions permitting vehicles to wait to enable people to board or alight; for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers; for local authority, Water Companies and Post Office purposes; if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles) or in connection with a funeral; to take on fuel, water or air at any garage; for the delivery or collection of goods and for loading or unloading; or the avoidance of an accident.

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.
