MILLGATE AND LIBRARY STREET, WIGAN - LOADING BAY AND DISABLED PARKING SPACE

NOTICE OF PROPOSALS

NOTICE IS HEREBY GIVEN that Wigan Borough Council, in exercise of the powers under Section 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984, proposes to make the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.196) Order XXXX.

The effect of the Order will be to introduce disabled persons parking spaces, Saturday – Sunday, 8am – 6pm, on:

- Millgate, Wigan (West) from a point 5 metres south of its junction with Hewlett Street to a point 19 metres south of its junction with Hewlett Street.
- Millgate, Wigan (West) from a point 15 metres north of its junction with Station Road to a point 30 metres north of its junction with Station Road.
- Library Street, Wigan (East) from a point 47 metres south of its junction with Hewlett Street to a point 63 metres south of its junction with Hewlett Street.

There will be limited exceptions permitting vehicles to wait; road works and works by statutory undertakers; for local authority, Water Companies and Post Office purposes; if the vehicles are fire service or police vehicles or ambulances, (liveried vehicles) or in connection with a funeral.

The effect of the Order will be to revoke loading, Monday – Saturday, 8am – 6pm, on:

- Millgate, Wigan (West) from a point 5 metres south of its junction with Hewlett Street to a point 19 metres south of its junction with Hewlett Street.
- Millgate, Wigan (South) from a point 99 metres east of the building line of the town hall adjacent to Hewlett Street to a point 114 metres east of the building line of the town hall adjacent to Hewlett Street.
- Library Street, Wigan (North) from a point 47 metres east of its junction with Hewlett Street to a point 63 metres east of its junction with Hewlett Street.

The effect of the Order will be to introduce loading, Monday – Friday, 8am – 6pm, on:

- Millgate, Wigan (West) from a point 5 metres south of its junction with Hewlett Street to a point 19 metres south of its junction with Hewlett Street.
- Millgate, Wigan (West) from a point 15 metres north of its junction with Station Road to a point 30 metres north of its junction with Station Road.
- Library Street (East) from a point 47 metres south of its junction with Hewlett Street to a point 63 metres south of its junction with Hewlett Street.

The Order also provides that if any vehicle is left in any road or length of road affected by the Order in contravention of any provision of the Order a penalty charge (in the amount set by the Council) shall be payable and/or the vehicle may be removed.
